## ***OFA Fiscal Note***

### ***Reduces Cost In Bill***

The amendment, which reduces costs in the underlying bill, removes General Obligation bond authorizations of \$25 million in FY 20 and \$25 million in FY 21 and potential debt service payments associated with such authorizations.
