**Wednesday, February 26, 2020**

The House of Representatives was called to order at 12:00 o'clock p.m., Speaker Joe Aresimowicz in the Chair.

Prayer was offered by House Chaplain, Rabbi Alan Lefkowitz of Windsor, Connecticut.

The following is the prayer:

### **INTRODUCTION OF BILLS HOUSE AND SENATE BILLS**

On motion of Representative Ritter of the 1st District, the first reading of the following bills and resolutions was waived, the list of bills and resolutions as prepared by the Clerks was accepted, and the bills and resolutions referred to the committees as indicated thereon in concurrence.

#### **GENERAL LAW**

**H.B. No. 5293 (RAISED) GENERAL LAW. 'AN ACT CONCERNING MUNICIPALITIES AND THE SALE OF ALCOHOLIC LIQUOR'**, to streamline the municipal voting process regarding the sale of alcoholic liquor.

**H.B. No. 5294 (RAISED) GENERAL LAW. 'AN ACT CONCERNING AUTO GLASS EMERGENCY TEMPORARY TECHNICIANS'**, to establish an auto glass temporary license to allow auto glass companies doing business in the state to perform auto glass work in the event of a state disaster or emergency.

**H.B. No. 5295 (RAISED) GENERAL LAW. 'AN ACT CONCERNING REVISIONS TO MEDICAL MARIJUANA STATUTES'**, to make various revisions to the medical marijuana program.

**H.B. No. 5296 (RAISED) GENERAL LAW. 'AN ACT CONCERNING CASH REFUNDS FOR THE BALANCE OF A GIFT CARD'**, to increase the minimum balance amount for which a consumer using a gift card may request a cash refund.

**H.B. No. 5297 (RAISED) GENERAL LAW. 'AN ACT CONCERNING TOBACCO BARS'**, to allow for the expansion, change in location and establishment of tobacco bars.

**H.B. No. 5298 (RAISED) GENERAL LAW. 'AN ACT CONCERNING CHARITABLE ORGANIZATION TRANSPARENCY'**, to require charitable organizations to disclose their registration numbers and certain financial information when soliciting funds.

#### PLANNING AND DEVELOPMENT

**H.B. No. 5299 (RAISED) PLANNING AND DEVELOPMENT. 'AN ACT CONCERNING THE MOTOR VEHICLE MILL RATE AND MOTOR VEHICLES REGISTERED OUT OF STATE'**, to permit municipalities to establish a mill rate for certain motor vehicles that are not registered in this state but that are statutorily subject to property tax in this state.

**H.B. No. 5300 (RAISED) PLANNING AND DEVELOPMENT. 'AN ACT ESTABLISHING A MORATORIUM ON THE INSTALLATION OF RECYCLED TIRE RUBBER AT MUNICIPAL AND PUBLIC SCHOOL PLAYGROUNDS'**, to establish a moratorium on the installation of crumb rubber ground covers at municipal and public school playgrounds.

**H.B. No. 5301 (RAISED) PLANNING AND DEVELOPMENT. 'AN ACT REQUIRING THE REMITTANCE OF SUPPLEMENTAL GRANT AWARDS TO LOCAL VOLUNTEER FIRE COMPANIES'**, to require the State Fire Administrator to remit one hundred dollars or an equivalent amount in credits to a volunteer fire company that provides an emergency response service on certain highways.

**H.B. No. 5302 (RAISED) PLANNING AND DEVELOPMENT. 'AN ACT CONCERNING ABANDONED AND BLIGHTED PROPERTY RECEIVERSHIP'**, to remove the municipal population threshold for certain parties to petition the Superior Court for appointment of a receiver for a blighted and abandoned property.

**H.B. No. 5303 (RAISED) PLANNING AND DEVELOPMENT. 'AN ACT CONCERNING TRAINING FOR CERTAIN PLANNING AND ZONING OFFICIALS'**, to allow municipalities to require training for members of planning commissions, zoning commissions, combined planning and zoning commissions and zoning boards of appeals.

**H.B. No. 5304 (RAISED) PLANNING AND DEVELOPMENT. 'AN ACT CONCERNING BOARD OF EDUCATION VACANCIES'**, to (1) specify that, for any vacancy on a local board of education that has not been filled within thirty days of its occurrence, only the remaining members of such board can fill such vacancy, and (2) require the individual selected by such remaining members to take the oath of office within sixty days after being so selected in order to fill such vacancy.

#### HUMAN SERVICES

**H.B. No. 5305 (RAISED) HUMAN SERVICES. 'AN ACT CONCERNING THE DEPARTMENT OF AGING AND DISABILITY SERVICES'**, to amend or repeal statutes concerning the Department of Aging and Disability Services.

**H.B. No. 5306 (RAISED) HUMAN SERVICES. 'AN ACT CONCERNING TEMPORARY STATE SERVICES FOR VICTIMS OF DOMESTIC VIOLENCE'**, to

expedite nutritional assistance, child care benefits and cash assistance for victims of domestic violence.

**H.B. No. 5307 (RAISED) HUMAN SERVICES. 'AN ACT CONCERNING DEPARTMENT OF SOCIAL SERVICES' PAYMENT SUSPENSIONS'**, to give providers of social services due process protections before payment is suspended by the Department of Social Services.

**H.B. No. 5308 (RAISED) HUMAN SERVICES. 'AN ACT REQUIRING THE DEPARTMENT OF SOCIAL SERVICES TO WORK WITH THE UNITED STATES DEPARTMENT OF AGRICULTURE TO EXPLORE CERTAIN SUPPLEMENTAL NUTRITION ASSISTANCE OPTIONS'**, to require the Department of Social Services to explore options for providing supplemental nutrition assistance benefits.

**H.B. No. 5309 (RAISED) HUMAN SERVICES. 'AN ACT CONCERNING MEDICAID AUDITS'**, to eliminate extrapolation of provider clerical errors in Medicaid audits and limit recovery by the state against such providers to any resulting overpayment and state administrative expenses related to investigation of the clerical error.

**H.B. No. 5310 (RAISED) HUMAN SERVICES. 'AN ACT ELIMINATING STATE RECOVERY OF PUBLIC ASSISTANCE EXCEPT AS REQUIRED UNDER FEDERAL LAW'**, to eliminate recovery of public assistance payments from beneficiaries except as required under federal law.

**H.B. No. 5311 (RAISED) HUMAN SERVICES. 'AN ACT CONCERNING A BILL OF RIGHTS FOR POST-SECONDARY STUDENTS WITH AUTISM SPECTRUM DISORDER'**, to ensure students with autism spectrum disorder have the necessary support to achieve success at state institutions of higher education.

#### PUBLIC SAFETY AND SECURITY

**H.B. No. 5312 (RAISED) PUBLIC SAFETY AND SECURITY. 'AN ACT CONCERNING WARRANTIES APPLICABLE TO POLICE, FIRE AND OTHER MUNICIPAL VEHICLES'**, to expand the automobile lemon law to cover municipal vehicles.

**H.B. No. 5313 (RAISED) PUBLIC SAFETY AND SECURITY. 'AN ACT CONCERNING POLICE REPORTS OF MOTOR VEHICLE ACCIDENTS'**, to eliminate a requirement that a police officer, in the officer's report of a motor vehicle accident involving a death, reach a conclusion as to the cause of the accident or refer the case to the appropriate state's attorney.

**H.B. No. 5314 (RAISED) PUBLIC SAFETY AND SECURITY. 'AN ACT CONCERNING BEST PRACTICES FOR WELLNESS CHECKS BY POLICE OFFICERS'**, to require the Department of Emergency Services and Public Protection to identify best practices for police officers to follow when conducting wellness checks and distribute a report of such best practices to local police departments.

**H.B. No. 5315 (RAISED) PUBLIC SAFETY AND SECURITY. 'AN ACT CONCERNING STREET RACING'**, to subject motor vehicle operators engaging in demonstrations of speed or skill on public highways to the same penalties as street racing.

**H.B. No. 5316 (RAISED) PUBLIC SAFETY AND SECURITY. 'AN ACT INCREASING FINES FOR OPERATING SNOWMOBILES, ALL-TERRAIN VEHICLES, DIRT BIKES AND MINI-MOTORCYCLES IN VIOLATION OF A MUNICIPAL ORDINANCE'**, to increase the maximum fines for operating a snowmobile, all-terrain vehicle, dirt bike or mini-motorcycle in violation of a municipal ordinance.

**H.B. No. 5317 (RAISED) PUBLIC SAFETY AND SECURITY. 'AN ACT CONCERNING PURCHASE OF OPIOID ANTAGONIST AND CARTRIDGE INJECTOR PRODUCTS FOR LAW ENFORCEMENT USE'**, to require the Commissioner of Administrative Services, in conjunction with the Department of Emergency Services and Public Protection, to enter cooperative purchasing plans with municipalities to provide opioid antagonist and cartridge injector products for use by police officers in the state.

**H.B. No. 5318 (RAISED) PUBLIC SAFETY AND SECURITY. 'AN ACT REQUIRING A STUDY OF TECHNOLOGY THAT POLICE OFFICERS, FIREFIGHTERS AND EMERGENCY MEDICAL SERVICES PERSONNEL MAY USE WHEN RESPONDING TO OPIOID OVERDOSES'**, to require a study of technology that police officers, firefighters and emergency medical services personnel may use when responding to opioid overdoses.

**H.B. No. 5319 (RAISED) PUBLIC SAFETY AND SECURITY. 'AN ACT EXEMPTING VOLUNTEER FIRE COMPANIES AND DEPARTMENTS AND VOLUNTEER AMBULANCE SERVICES AND COMPANIES FROM THE FEE FOR A CRIMINAL HISTORY RECORDS CHECK'**, to exempt volunteer fire companies and departments and volunteer ambulance services and companies from the fee for a criminal history records check.

**H.B. No. 5320 (RAISED) PUBLIC SAFETY AND SECURITY. 'AN ACT CONCERNING OPERATION OF THE LOTTERY BY THE DEPARTMENT OF CONSUMER PROTECTION'**, to terminate the Connecticut Lottery Corporation and transfer responsibility for operating the lottery to the Department of Consumer Protection.

**H.B. No. 5321 (RAISED) PUBLIC SAFETY AND SECURITY. 'AN ACT ESTABLISHING A TASK FORCE ON PUBLIC SAFETY ANSWERING POINT CONSOLIDATION'**, to establish a task force to study and make recommendations on public safety answering point consolidation.

**H.B. No. 5322 (RAISED) PUBLIC SAFETY AND SECURITY. 'AN ACT CONCERNING RELIABILITY OF 9-1-1 CALL SERVICE'**, to ensure continuous and uninterrupted 9-1-1 call service to public safety answering points.

#### TRANSPORTATION

**H.B. No. 5323 (RAISED) TRANSPORTATION. 'AN ACT REQUIRING THE DEPARTMENT OF TRANSPORTATION TO DEVELOP A TRANSPORTATION INFRASTRUCTURE INVESTMENT PLAN'**, to require the Department of Transportation, in consultation with the Office of Policy and Management, to develop a transportation infrastructure investment plan.

**H.B. No. 5324 (RAISED) TRANSPORTATION. 'AN ACT CONCERNING PEDESTRIAN SAFETY AT CROSSWALKS, SPEED LIMITS IN MUNICIPALITIES, FINES AND CHARGES FOR CERTAIN VIOLATIONS AND THE GREENWAYS COMMEMORATIVE ACCOUNT'**, to (1) require motorists to grant the right-of-way to pedestrians who affirmatively indicate their intention to cross the road in a crosswalk; (2) allow local traffic authorities to establish lower speed limits on streets under their jurisdiction by holding a public hearing regarding such speed limits and providing notification of such speed limits to the Office of the State Traffic Administration; (3) increase the fine for operating a motor vehicle while using a hand-held mobile telephone or electronic device; (4) increase the additional fee provided to municipalities for certain traffic violations; (5) establish a fine for opening the door of a motor vehicle in a way that impedes the travel of a pedestrian or a person riding a bicycle; and (6) establish the greenways commemorative account.

#### GENERAL LAW

**S.B. No. 250 (RAISED) GENERAL LAW. 'AN ACT CONCERNING FLAT GLASS OCCUPATIONAL LICENSING'**, to require the Commissioner of Consumer Protection to amend existing regulations regarding flat glass occupational licensing.

**S.B. No. 251 (RAISED) GENERAL LAW. 'AN ACT CONCERNING THE AVAILABILITY OF GENERIC PHARMACEUTICALS'**, to preserve consumer access to affordable generic drugs.

**S.B. No. 252 (RAISED) GENERAL LAW. 'AN ACT CONCERNING NUISANCE CALLS'**, to require telemarketers to inform consumers they may request their telephone numbers to be placed on the do not call list.

**S.B. No. 253 (RAISED) GENERAL LAW. 'AN ACT CONCERNING FAIR REIMBURSEMENT TO RETAIL DEALERS OF POWER EQUIPMENT'**, to ensure fair reimbursement to retail dealers of power equipment regarding certain warranty claims.

**S.B. No. 254 (RAISED) GENERAL LAW. 'AN ACT CONCERNING CERTAIN ALCOHOLIC BEVERAGE SYSTEMS'**, to allow certain alcoholic liquor permittees to use self-pour automated systems.

#### **PLANNING AND DEVELOPMENT**

**S.B. No. 255 (RAISED) PLANNING AND DEVELOPMENT. 'AN ACT CONCERNING INVESTMENT OF CERTAIN MUNICIPAL FUNDS'**, to allow for the investment of funds held in certain trusts established by municipalities, or in which municipalities may participate, to be invested in trust funds administered, held or invested by the Treasurer.

**S.B. No. 256 (RAISED) PLANNING AND DEVELOPMENT. 'AN ACT INCREASING THE PROPERTY TAX EXEMPTION FOR FARM BUILDINGS'**, to increase from one hundred thousand dollars to one hundred fifty thousand dollars the municipal property tax exemption for buildings used (1) actually and exclusively in farming, or (2) to provide housing for seasonal employees of a farmer.

**S.B. No. 257 (RAISED) PLANNING AND DEVELOPMENT. 'AN ACT CONCERNING COMMUNITY INVESTMENT BOARDS AND NEIGHBORHOOD ASSISTANCE'**, to (1) require certain municipalities to establish community investment boards to identify priorities for the use of municipal revenue sharing grants and select grants for payment in lieu of taxes, (2) require the Office of Policy and Management to accept proposals for solutions to problems specific to urban areas and establish pilot programs to implement such proposals, and (3) establish a task force to study issues concerning nonprofit providers.

**S.B. No. 258 (RAISED) PLANNING AND DEVELOPMENT. 'AN ACT CONCERNING CERTIFICATES OF APPROVAL FOR THE LOCATION OF MOTOR VEHICLE DEALERSHIPS AND REPAIR SHOPS'**, to specify that applicants for licenses for dealing in or repairing motor vehicles in towns or cities having zoning commissions, combined planning and zoning commissions and boards of appeals shall obtain certificates of approval of location from the town or city's zoning commission rather than its board of appeals.

**S.B. No. 259 (RAISED) PLANNING AND DEVELOPMENT. 'AN ACT CONCERNING NOTICE OF TAX DELINQUENCY'**, to (1) recognize, in certain situations, that other individuals perform tax collection duties, (2) specify that certain actions shall serve as constructive notice to certain individuals for purposes of tax delinquency sales of real property, and (3) revise a certain provision to account for instances in which the redemption by a delinquent taxpayer of the real property at issue occurs prior to the delinquency sale of such property.

**S.B. No. 260 (RAISED) PLANNING AND DEVELOPMENT. 'AN ACT EXTENDING THE MUNICIPAL REVALUATION DEADLINE FOR THE TOWN OF HAMDEN BY ONE YEAR'**, to extend the municipal revaluation deadline for the town of Hamden by one year.

**PUBLIC SAFETY AND SECURITY**

**S.B. No. 261 (RAISED) PUBLIC SAFETY AND SECURITY. 'AN ACT DESIGNATING SPECIAL POLICE OFFICERS IN THE DEPARTMENT OF REVENUE SERVICES AS PEACE OFFICERS'**, to redefine "peace officer" to include a special police officer in the Department of Revenue Services and to make conforming changes.

**S.B. No. 262 (RAISED) PUBLIC SAFETY AND SECURITY. 'AN ACT REQUIRING A STUDY OF THE USE OF COMBUSTIBLE GAS DETECTORS'**, to study whether to require the use of combustible gas detectors in new construction with natural gas connections.

**S.B. No. 263 (RAISED) PUBLIC SAFETY AND SECURITY. 'AN ACT ALLOWING AN EMERGENCY CONTACT ACCESS TO A DWELLING UNIT WITHOUT THE TENANT'S CONSENT UNDER CERTAIN CIRCUMSTANCES'**, to allow a person designated as an emergency contact of a tenant of a dwelling unit to access the unit under certain circumstances.

**S.B. No. 264 (RAISED) PUBLIC SAFETY AND SECURITY. 'AN ACT CONCERNING MOTOR VEHICLE INSPECTORS AND BUILDING SECURITY'**, to allow the Commissioner of Motor Vehicles to nominate, and the Commissioner of Emergency Services and Public Protection to appoint, motor vehicle inspectors to serve as special police officers at Department of Motor Vehicles' buildings and on department lands.

**S.B. No. 265 (RAISED) PUBLIC SAFETY AND SECURITY. 'AN ACT CONCERNING REIMBURSEMENT OF FIREFIGHTER TRAINING COSTS'**, to require a fire department to be reimbursed for a portion of the costs of the entry-level training of a firefighter who is subsequently hired by another department within two years of the completion of the firefighter's entry-level training.

**S.B. No. 266 (RAISED) PUBLIC SAFETY AND SECURITY. 'AN ACT CONCERNING BODY ARMOR FOR FIREFIGHTERS AND EMERGENCY MEDICAL SERVICES PERSONNEL'**, to (1) allow firefighters, fire departments, emergency services personnel and emergency medical service organizations to purchase or receive body armor without meeting the transferor of such body armor in person, and (2) require fire departments and emergency medical service organizations to equip their vehicles with body armor.

**S.B. No. 267 (RAISED) PUBLIC SAFETY AND SECURITY. 'AN ACT ESTABLISHING A DEPARTMENT OF CIVILIAN JUSTICE'**, to establish a Department of Civilian Justice to receive and investigate complaints from a police officer alleging misconduct by another police officer in the performance of the officer's duties.

**S.B. No. 268 (RAISED) PUBLIC SAFETY AND SECURITY. 'AN ACT CONCERNING INTEREST ON LOTTERY SALES AGENT DELINQUENCY ASSESSMENTS'**, to (1) specify that simple interest is charged on delinquency assessments of lottery sales agents, and (2) allow an agent whose delinquency assessment remains due and was subject to compounding interest to request a hardship waiver from the Commissioner of Consumer Protection to recalculate the interest owed.

**S.B. No. 269 (RAISED) PUBLIC SAFETY AND SECURITY. 'AN ACT CONCERNING CERTIFICATION OF INDEPENDENT INSPECTORS AND INSPECTION FIRMS TO PERFORM ELEVATOR, ESCALATOR AND STATE BUILDING CODE INSPECTIONS'**,

to establish a program to certify independent inspectors and inspection firms to perform State Building Code and elevator and escalator inspections.

**S.B. No. 270 (RAISED) PUBLIC SAFETY AND SECURITY. 'AN ACT REQUIRING POLICE OFFICERS AND VEHICLES WITH BLUE LIGHTS TO BE STATIONED IN CERTAIN HIGHWAY WORK ZONES'**, to require the Department of Transportation to ensure that a state or local public safety officer and a vehicle displaying blue lights are stationed within certain highway work zones.

#### TRANSPORTATION

**S.B. No. 271 (RAISED) TRANSPORTATION. 'AN ACT CONCERNING THE FISCAL ACCOUNTABILITY AND SUSTAINABLE TRANSPORTATION REFORM PLAN'**, to (1) establish a Transportation Strategy and Advisory Board, and a Connecticut and New York Railroad Strategy Board; (2) require the Commissioner of Transportation to provide certain information to the Transportation Strategy and Advisory Board and the Connecticut and New York Railroad Strategy Board; (3) limit the aggregate maximum amount of TIFIA and RRIF loan agreements the state can enter into for the period commencing on July 1, 2022, and ending on December 31, 2030; (4) transfer the sum of one billion five hundred million dollars from the Budget Reserve Fund to the State Employees Retirement Fund for the purpose of paying unfunded past service liability; and (5) require the Auditors of Public Accounts to conduct certain audits of the Department of Transportation.

#### HUMAN SERVICES

**S.B. No. 272 (RAISED) HUMAN SERVICES. 'AN ACT ADDING ACUPUNCTURISTS AND CHIROPRACTORS TO THE LIST OF PERMISSIBLE REIMBURSABLE MEDICAID SERVICES'**, to provide Medicaid reimbursement for chiropractors and acupuncturists.

**S.B. No. 273 (RAISED) HUMAN SERVICES. 'AN ACT CREATING A TASK FORCE TO CONSIDER DUAL DELIVERY OF STATE-ADMINISTERED HUMAN SERVICES BY COMMUNITY NONPROFIT AGENCIES'**, to explore more efficient and effective delivery of state-administered human services via provision of more services by community nonprofit agencies.

**S.B. No. 274 (RAISED) HUMAN SERVICES. 'AN ACT CONCERNING FUNDING FOR PLANNED PARENTHOOD AND OTHER FAMILY PLANNING CLINICS'**, to offset the loss of federal funds for family planning clinics.

**S.B. No. 275 (RAISED) HUMAN SERVICES. 'AN ACT REQUIRING FAMILY NOTIFICATIONS IN STATE ESTATE RECOVERIES'**, to require the state to make efforts to notify immediate family members before taking over the administration of a decedent's estate for payment of state assistance or care provided to the decedent.

**S.B. No. 276 (RAISED) HUMAN SERVICES. 'AN ACT REQUIRING DRIVERS OF PARATRANSIT VEHICLES TO REPORT SUSPECTED ABUSE, NEGLECT OR EXPLOITATION OF ELDERLY PERSONS'**, to make drivers of paratransit vehicles mandated reporters of suspected abuse, neglect, exploitation or abandonment of elderly persons.
