

## Subsequent Amendments to Public Act 13-3

### Issue

This report identifies the (1) provisions in, and codification of, [PA 13-3](#), An Act Concerning Gun Violence Prevention and Children's Safety, and (2) parts of the act that the Connecticut General Assembly subsequently amended through 2020.

### Summary

PA 13-3, which passed in response to the December 2012 tragedy at Sandy Hook Elementary School in Newtown, Connecticut, made extensive changes in the state's gun laws. It also made changes to laws concerning mental health insurance coverage and services, security measures for K-12 public schools and institutions of higher education, and actions surrounding domestic violence incidents.

Table 1 lists the 99 sections of PA 13-3 in numerical order, details where each section was codified in the Connecticut General Statutes, briefly describes the content of each statute or act section, and then identifies subsequent amendments to each of the act's sections. Table 2 organizes the act by subject matter and then lists its provisions in numerical order, primarily based on the codified statutory numbering of each section. (Please note that this report does not include subsequent legislation that may have built on the content or concepts of PA 13-3 but did not directly modify the same provisions changed by that act.)
