To be exact it was insurance department same portion of government that protects our hippa rights. The state doesn't care to allow justice in my case. They feel above the law.

Ct legislators I know too well what happens when the law fails to disarm their own abuse. That is why I urge you to take action and stop this crisis of crimes committed against us the constituent. Change how the commission works now!

Authorize my case and to build a legislature protecting our rights. To disarm the government from their own unconstitutional abuse.

Right now there are loopholes in state and federal laws that some legislators use to abuse power, the claims commission says she's not back up on resent communication but yet my case has been in her hands for years. Our constitutional rights should not be used for political games or gain. Hippa law should be argued to expand adding government as they handle our medical records uncaringly. These loopholes make us vulnerable to those elected who don't take our rights seriously. This is a death sentence to us as getting justice is for those who have the money to afford it. Even that in itself is a racist crime from our government to our people.

Our lawmakers need to build a bill protecting us from government and protect our Hippa and privacy rights.

Christy, then tell me why you have had my case for years. Why, knowing the state admitted to the crime of the acquisition, access, use, disclosure of protected health information compromising the security and privacy of the protected health information.

The state forced me to share my story, first, for not righting a wrong, second, for those in oppressed communities like mine who live with the state's crimes as debts unpaid uncaringly. For you, I am sorry!

Now, I live each day to fight for our rights. That is why I tell you my story. Advocating for change.

Dear Connecticut Resident, tell your representative any type of hindrance from the state against its people. It's an act of racism and a pure health disparity. No rest until legislators do right by us, WE the people.

To those great legislators: Thank you for taking action and for honoring our constitutional rights. The ones my father, rest in peace, fought for as a Vietnam veteran, a parachuter. I lived through the war with him. His health was compromised by his time as a military man. Why are my rights stolen by the government?

Thank you for taking action as I can not be the only one living in oppression from state immunity and archaic claims commission inner operatives and they who should be protecting us, our government.
