***AN ACT CONCERNING THE ONLINE SALE AND DELIVERY OF
ELECTRONIC NICOTINE DELIVERY SYSTEMS AND VAPOR
PRODUCTS.***

Be it enacted by the Senate and House of Representatives in General Assembly convened:

1 Section 1. Section 21a-418 of the general statutes is repealed and the
2 following is substituted in lieu thereof (*Effective July 1, 2021*):

3 (a) As used in this section:

4 (1) "Person" means any individual, firm, fiduciary, partnership,
5 corporation, limited liability company, trust or association, however
6 formed;

7 (2) "Electronic nicotine delivery system" has the same meaning as
8 provided in section 21a-415; and

9 (3) "Vapor product" has the same meaning as provided in section 21a-
10 415.

11 (b) A person with an electronic nicotine delivery system certificate of
12 dealer registration, when selling and shipping an electronic nicotine

13 delivery system or a vapor product directly to a consumer in the state,
 14 shall: (1) [Ensure] Require such consumer to provide a copy of such
 15 consumer's valid motor vehicle operator's license or valid identity card,
 16 as described in section 1-1h, at the time of sale; (2) ensure that the name
 17 on such consumer's valid motor vehicle operator's license or valid
 18 identity card is identical to the name on the credit card, charge card,
 19 debit card or other method of payment used to purchase such system or
 20 product at the time of sale; (3) ensure that the shipping labels on all
 21 containers of an electronic nicotine delivery system or vapor product
 22 [shipped directly to a consumer in the state conspicuously states]
 23 conspicuously state the following: "CONTAINS AN ELECTRONIC
 24 NICOTINE DELIVERY SYSTEM OR VAPOR PRODUCT –
 25 SIGNATURE OF A PERSON AGE 21 OR OLDER REQUIRED FOR
 26 DELIVERY"; and [(2)] (4) obtain the signature of a person [age] twenty-
 27 one years of age or older at the shipping address prior to delivery, after
 28 requiring the signer to demonstrate that he or she is age twenty-one or
 29 older by providing a valid motor vehicle operator's license or a valid
 30 identity card, [described in section 1-1h.]

This act shall take effect as follows and shall amend the following sections:		
Section 1	July 1, 2021	21a-418

Statement of Purpose:

To require online sellers of electronic nicotine delivery systems and vapor products to require purchasers of such systems and products to (1) provide identification at the time of purchase, and (2) ensure that the name on such identification matches the name on the method of payment used to make the purchase.
