Title: AN ACT CONCERNING THE REMOVAL OF RESTRICTIONS ON OWNERSHIP OR OCCUPANCY OF REAL PROPERTY BASED ON RACE AND ELIMINATION OF THE RACE DESIGNATION ON MARRIAGE LICENSES.

Statement of Purpose: To prohibit restrictive covenants based on race, to provide a process to remove such covenants from instruments recorded on the land records in this state and to eliminate the race designation on marriage licenses.
