### **INTRODUCTION OF BILLS SENATE AND HOUSE BILLS AND RESOLUTIONS**

In accordance with the provisions of Senate Rule 9(d), the first reading of the following bills and resolutions was waived, the list of bills and resolutions as prepared by the Clerks was accepted, and the bills and resolutions referred to the Committees as indicated thereon in concurrence:

#### **COMMITTEE ON CHILDREN**

S.B. No. **35** (COMM) COMMITTEE ON CHILDREN. 'AN ACT CONCERNING FINANCIAL ASSISTANCE FOR POST-SECONDARY EDUCATION EXPENSES FOR CERTAIN INDIVIDUALS ADOPTED THROUGH THE DEPARTMENT OF CHILDREN AND FAMILIES' FOSTER CARE PROGRAM', to expand the policy for financial assistance for post-secondary education expenses to youths adopted on or after January 1, 2001 through the Department of Children and Families foster care program.

S.B. No. **36** (COMM) COMMITTEE ON CHILDREN. 'AN ACT CONCERNING SCHOOL LUNCH DEBT', to prohibit disciplinary action against public school children for unpaid school lunch charges and to allow any public or private parties to donate to payoff such debt.

Proposed S.B. No. **616** SEN. SAMPSON, 16th DIST. 'AN ACT ELIMINATING CERTAIN FUNDING FOR THE XL CENTER AND THE CITY OF HARTFORD AND INCREASING FUNDING FOR SCHOOL RESOURCE OFFICERS', to provide funding for school safety

programs in all towns and cities in the state by reducing certain state funding for the XL Center and the city of Hartford.

Proposed S.B. No. **617** SEN. SAMPSON, 16th DIST. 'AN ACT PREVENTING OVERTIME PAYMENTS FROM BEING USED TO CALCULATE THE RETIREMENT INCOME OF STATE EMPLOYEES', to prohibit the calculation of a state employee's pension from including overtime pay.

Proposed S.B. No. **618** SEN. SAMPSON, 16th DIST. 'AN ACT REDUCING NONEDUCATION AID TO THE CITY OF HARTFORD', to reverse the fiscal impact to the state of the debt service agreement between the state and the city of Hartford.

Proposed S.B. No. **619** SEN. SAMPSON, 16th DIST. 'AN ACT PROHIBITING THE USE OF STATE FUNDS FOR BALLPARKS FOR PROFESSIONAL SPORTS TEAMS', to prevent the misuse of state funds.

Proposed S.B. No. **620** SEN. SAMPSON, 16th DIST. 'AN ACT CONCERNING A PUBLIC HEARING REQUIREMENT FOR BUDGET EARMARKS', to require public hearings for earmarks.

Proposed S.B. No. **623** SEN. SOMERS, 18th DIST. 'AN ACT CONCERNING A STUDY OF AN INTERMODAL TRANSPORTATION CENTER IN THE TOWN OF MYSTIC', to require the Department of Economic and Community Development to conduct a feasibility study regarding the establishment of an intermodal transportation center in the town of Mystic.

Proposed S.B. No. **625** SEN. OSTEN, 19th DIST.; SEN. ANWAR, 3rd DIST. 'AN ACT CONCERNING A DATABASE OF STATE BUSINESSES, SUPPLY CHAINS AND WORKFORCE TOOLS', to establish a database of state businesses, supply chains and workforce tools.

Proposed S.B. No. **626** SEN. MARTIN, 31st DIST.; REP. BETTS, 78th DIST. 'AN ACT ESTABLISHING AN ENTERPRISE ZONE IN THE TOWN OF PLYMOUTH', to encourage economic development in the town of Plymouth.

Proposed S.B. No. **627** SEN. MARONEY, 14th DIST. 'AN ACT CONCERNING OPPORTUNITY ZONES', to provide internships, support and financial assistance to businesses in federally designated opportunity zones.

RESIDENTS', to increase consumer choice in electric distribution services and products for municipal residents.

Proposed S.B. No. **629** SEN. SAMPSON, 16th DIST. 'AN ACT ELIMINATING A CHARGE ASSESSED TO END USE CUSTOMERS OF ELECTRIC SERVICES', to eliminate a surcharge assessed on electric bills which are deposited into the Clean Energy Fund.

Proposed S.B. No. **630** SEN. SAMPSON, 16th DIST. 'AN ACT REMOVING ENERGY PROCUREMENT AUTHORITY FROM THE DEPARTMENT OF ENERGY AND ENVIRONMENTAL PROTECTION', to remove energy procurement authority from the Department of Energy and Environmental Protection.

Proposed S.B. No. **631** SEN. SAMPSON, 16th DIST. 'AN ACT CONCERNING BATTERY STORAGE', to review the effectiveness of battery-storage technology and its impact on ratepayer bills.

'AN ACT CONCERNING A STUDY OF ENFORCEMENT JURISDICTION ON BODIES OF WATER AND ADJACENT ROADWAYS COVERING MORE THAN ONE JURISDICTION', to maintain public safety in areas that are covered by more than one jurisdiction, including Beach Pond in Voluntown.

Proposed S.B. No. **637** SEN. COHEN, 12th DIST.; SEN. NEEDLEMAN, 33rd DIST. 'AN ACT TEMPORARILY SUSPENDING THE SALES AND USE TAXES ON PERSONAL PROTECTIVE EQUIPMENT FOR BUSINESSES', to suspend, for businesses through the fiscal year ending June 30, 2023, the imposition of the sales and use taxes on the sale of and the storage, use or other consumption in this state of personal protective equipment.

Proposed S.B. No. **638** SEN. OSTEN, 19th DIST. 'AN ACT AUTHORIZING BONDS OF THE STATE FOR CAPITAL PROJECTS AT CERTAIN VOLUNTEER FIRE DEPARTMENTS', to provide funding for capital projects at certain volunteer fire departments.

Proposed S.B. No. **639** SEN. OSTEN, 19th DIST. 'AN ACT AUTHORIZING BONDS OF THE STATE FOR THE INSTALLATION OF SIDEWALKS IN THE TOWN OF LISBON', to provide funding for the installation of sidewalks in the town of Lisbon.

Proposed S.B. No. **641** SEN. LOONEY, 11th DIST. 'AN ACT REQUIRING MANUFACTURERS OF BRAND-NAME PRESCRIPTION DRUGS TO PROVIDE SAMPLES OF SUCH DRUGS TO MANUFACTURERS OF GENERIC PRESCRIPTION DRUGS', to promote competition in the prescription drug market by allowing developers of generic drugs and biosimilar products to obtain reference samples.

Proposed S.B. No. **642** SEN. SOMERS, 18th DIST. 'AN ACT CHANGING CONTINUING EDUCATION REQUIREMENTS FOR CERTAIN LICENSED PROFESSIONALS', to change continuing education requirements for certain licensed professionals.

'AN ACT ALLOWING MUNICIPALITIES TO CONTRIBUTE TO THE CONNECTICUT HIGHER EDUCATION TRUST AND 529 PLANS', to allow municipalities to contribute to the Connecticut Higher Education Trust and qualified tuition programs exempt from taxation under Section 529 of the Internal Revenue Code.

Proposed S.B. No. **652** SEN. MARONEY, 14th DIST. 'AN ACT ESTABLISHING A TAX CREDIT FOR DONATIONS TO THE ROBERTA B. WILLIS SCHOLARSHIP PROGRAM', to establish a tax credit for donations to the Roberta B. Willis Scholarship program.

'AN ACT CONCERNING MINORITY TEACHER RECRUITMENT', to market the minority teacher recruitment program, establish a mentorship program for minority teachers and establish a student loan forgiveness program for minority teachers who teach in certain school districts.

Proposed S.B. No. **658** SEN. LOONEY, 11th DIST. 'AN ACT REQUIRING EMPLOYERS TO RECALL LAID-OFF WORKERS IN ORDER OF SENIORITY', to provide protection for laid-off employees.

Proposed S.B. No. **659** SEN. FORMICA, 20th DIST. 'AN ACT ESTABLISHING AN OPIOID RECOVERY AND REFORM PILOT PROGRAM', to create an opioid recovery and reform pilot program to assist in employment opportunities.

Proposed S.B. No. **660** SEN. LOONEY, 11th DIST. 'AN ACT EXPANDING WORKERS' COMPENSATION BENEFITS FOR MENTAL OR EMOTIONAL IMPAIRMENTS SUFFERED

BY ALL WORKERS', to expand workers' compensation benefits for mental or emotional impairments to cover all workers.

Proposed S.B. No. **669** SEN. LOONEY, 11th DIST. 'AN ACT CONCERNING THE RIGHT OF A PUBLIC EMPLOYEE TO JOIN OR SUPPORT A UNION', to ensure workers continue to have the right to effective union representation.

'AN ACT CONCERNING COMMUNITY INVESTMENT BOARDS AND NEIGHBORHOOD ASSISTANCE', to (1) require certain municipalities to establish community investment boards to identify priorities for the use of municipal revenue sharing grants and select grants for payment in lieu of taxes, (2) require the Office of Policy and Management to accept proposals for solutions to problems specific to urban areas and establish pilot programs to implement such proposals, and (3) establish a task force to study issues concerning nonprofit providers.

Proposed S.B. No. **671** SEN. CABRERA, 17th DIST.; SEN. HARTLEY, 15th DIST.; REP. REBIMBAS, 70th DIST.; REP. LABRIOLA, 131st DIST. 'AN ACT AUTHORIZING THE BOROUGH OF NAUGATUCK TO ISSUE PENSION DEFICIT FUNDING BONDS', to authorize the borough of Naugatuck to issue an additional series of pension deficit funding bonds.

Proposed S.B. No. **674** SEN. MARONEY, 14th DIST.; SEN. WITKOS, 8th DIST. 'AN ACT CONCERNING THE INCLUSION OF COMPUTER SCIENCE AMONG THE STEM CREDIT REQUIREMENTS FOR HIGH SCHOOL GRADUATION', to include computer science among the STEM credit requirements of the high school graduation requirements.

Proposed S.B. No. **675** SEN. MARONEY, 14th DIST.; SEN. WITKOS, 8th DIST. 'AN ACT CONCERNING THE SUBMISSION OF PROGRESS REPORTS ON THE IMPLEMENTATION OF THE CONNECTICUT COMPUTER SCIENCE PLAN', to require the Department of Education to submit annual progress reports, through 2025, concerning the implementation of the Connecticut Computer Science Plan.

Proposed S.B. No. **676** SEN. MARONEY, 14th DIST. 'AN ACT PROHIBITING THE USE OF POLYSTYRENE PRODUCTS IN SCHOOLS', to ban the use of polystyrene products in public schools in the state.

Proposed S.B. No. **677** SEN. COHEN, 12th DIST. 'AN ACT CONCERNING THE COMPLETION OF AN ANTI-RACISM COURSE FOR PURPOSES OF EDUCATOR CERTIFICATION', to require the inclusion of an anti-racism course component as part of the Connecticut educator certification requirements.

Proposed S.B. No. **678** SEN. SLAP, 5th DIST.; SEN. HWANG, 28th DIST.; SEN. ANWAR, 3rd DIST.; SEN. OSTEN, 19th DIST. 'AN ACT CONCERNING THE INCLUSION OF ASIAN PACIFIC AMERICAN STUDIES IN THE SOCIAL STUDIES CURRICULUM', to include Asian Pacific American studies in the public school curriculum.

### PUBLIC HEALTH

Proposed S.B. No. **679** SEN. OSTEN, 19th DIST. 'AN ACT PROHIBITING SMOKING AT CERTAIN PRIVATE, NONPROFIT BEHAVIORAL HEALTH FACILITIES', to extend the smoking ban to private, nonprofit behavioral health facilities that are funded by or have a contract with the state.

Proposed S.B. No. **680** SEN. OSTEN, 19th DIST. 'AN ACT CONCERNING THE AVAILABILITY OF PUBLIC RESTROOMS', to aid members of the public with required access to a public restroom in any commercial or retail establishment.

Proposed S.B. No. **681** SEN. KISSEL, 7th DIST. 'AN ACT CONCERNING PATIENT ACCESS TO MEDICAL RECORDS', to allow a patient access to his or her medical records.

Proposed S.B. No. **682** SEN. OSTEN, 19th DIST. 'AN ACT CONCERNING A UNIVERSAL ASSESSMENT SYSTEM FOR SERVICES PROVIDED BY THE DEPARTMENT OF DEVELOPMENTAL SERVICES AND OTHER STATE AGENCIES', to authorize a universal assessment system for programs serving persons with intellectual disability or developmental disabilities and the establishment of an advisory committee that includes persons with intellectual disability or developmental disabilities, their families and advocates.

Proposed S.B. No. **683** SEN. LOONEY, 11th DIST. 'AN ACT CONCERNING HOSPITAL BILLING AND COLLECTION EFFORTS BY HOSPITALS AND COLLECTION AGENTS', to: (1) Restrict (A) the amount that a hospital or collection agent may recover from an uninsured or underinsured patient for the unpaid cost of health care, and (B) the manner in which a hospital or collection agent may secure or recover payment for the unpaid cost of health care; and (2) modify provisions concerning hospital billing practices to protect patients who receive health care at outpatient clinics that are owned by, or affiliated with, hospitals.

Proposed S.B. No. **685** SEN. FORMICA, 20th DIST. Proposed H.B. No. **6075** REP. GIBSON, 15th DIST. 'AN ACT CONCERNING DIRECT FLIGHTS FROM THE BRADLEY INTERNATIONAL AIRPORT TO JAMAICA', to require the Bradley International Airport to offer direct flights to Kingston, Jamaica.

Proposed H.B. No. **6076** REP. COMEY, 102nd DIST. 'AN ACT REDUCING EXCESSIVE NOISE FROM MOTOR VEHICLES', to reduce excessive noise from motor vehicles that are the subject of two or more written warnings or violations within a period of six months by suspending the registrations of such motorcycles.

H.B. No. **6105** (RAISED) PLANNING AND DEVELOPMENT. 'AN ACT CONCERNING ACCESS TO ORIGINAL BIRTH CERTIFICATES BY ADULT ADOPTED PERSONS', to grant access to original birth records to all adopted persons eighteen years of age or older who were born in Connecticut regardless of date of birth.

H.B. No. **6106** (RAISED) PLANNING AND DEVELOPMENT. 'AN ACT CONCERNING THE PROPERTY TAX EXEMPTION FOR CERTAIN RENEWABLE ENERGY SOURCES AND NONRESIDENTIAL HYDROPOWER FACILITIES', to revise the property tax exemption for certain renewable energy sources and hydropower facilities.

H.B. No. **6107** (RAISED) PLANNING AND DEVELOPMENT. 'AN ACT CONCERNING THE REORGANIZATION OF THE ZONING ENABLING ACT AND THE PROMOTION OF MUNICIPAL COMPLIANCE', to (1) restructure the Zoning Enabling Act for clarity, (2) promote the purposes of the federal Fair Housing Act, (3) provide an administrative mechanism to promote compliance with municipal affordable housing plans, and (4) require the Secretary of the Office of Policy and Management to convene a working group to study municipal affordable housing plans and zoning regulations.

H.B. No. **6110** (RAISED) COMMITTEE ON CHILDREN. 'AN ACT CONCERNING THE ONLINE SALE AND DELIVERY OF ELECTRONIC NICOTINE DELIVERY SYSTEMS AND VAPOR PRODUCTS', to require online sellers of electronic nicotine delivery systems and vapor products to require purchasers of such systems and products to (1) provide identification at the

time of purchase, and (2) ensure that the name on such identification matches the name on the method of payment used to make the purchase.

H.B. No. **6111** (RAISED) COMMITTEE ON CHILDREN. 'AN ACT ESTABLISHING A YOUTH SUICIDE PREVENTION PROGRAM', to require the Youth Suicide Advisory Board and the Office of the Child Advocate to establish a youth suicide prevention pilot program.

H.B. No. **6112** (RAISED) COMMITTEE ON CHILDREN. 'AN ACT REQUIRING A SURVEY OF COURT-INVOLVED YOUTHS', to require the Court Support Services Division of the Judicial Branch to conduct a survey of court-involved youths in order to ascertain the need for additional or improved services for lesbian, gay, bisexual, transgender and queer youths.

H.B. No. **6113** (RAISED) COMMITTEE ON CHILDREN. 'AN ACT REQUIRING THE PROVISION OF INFORMATION CONCERNING CHILD SEXUAL ABUSE', to require the Department of Children and Families to develop, and operators of youth athletic activities and licensees of youth camps to distribute, information concerning appropriate interactions with children and child sexual abuse.
