### INTRODUCTION OF BILLS SENATE AND HOUSE BILLS AND RESOLUTIONS

#### GOVERNMENT ADMINISTRATION AND ELECTIONS

S.B. No. **5** (COMM) GOVERNMENT ADMINISTRATION AND ELECTIONS. 'AN ACT CONCERNING INCREASED OPPORTUNITIES FOR ABSENTEE VOTING, SAFE AND SECURE IN-PERSON VOTING AND VOTER REGISTRATION', to make several changes to election laws designed to increase opportunities for absentee voting, safe and secure in-person voting and voter registration.

#### COMMERCE

S.B. No. **167** (COMM) COMMERCE. 'AN ACT CONCERNING THE DISPOSITION OF THE FORMER SEASIDE SANATORIUM FACILITY', to require the Commissioner of Energy

and Environmental Protection to issue a request for information for low-impact, residential uses for the former Seaside Sanatorium Facility in the town of Waterford.

### APPROPRIATIONS

S.B. No. **705** (COMM) APPROPRIATIONS. 'AN ACT ESTABLISHING AN OFFICE OF PANDEMIC AND PUBLIC HEALTH PREPAREDNESS', to establish an Office of Pandemic and Public Health Preparedness.

### GOVERNMENT ADMINISTRATION AND ELECTIONS

S.B. No. **820** (COMM) GOVERNMENT ADMINISTRATION AND ELECTIONS. 'AN ACT CONCERNING A STATE VOTING RIGHTS ACT', to afford mechanisms for the challenge of certain election administration laws, practices or procedures that may impair the electoral rights of certain protected classes of individuals.

S.B. No. **1078** (RAISED) GOVERNMENT ADMINISTRATION AND ELECTIONS. 'AN ACT CONCERNING CAMPAIGN FINANCE LAWS', to (1) specify that certain online solicitations for political contributions are excluded from the definition of "expenditure", (2) allow certain individuals or entities to make contributions to legislative candidate committees and caucus committees, and (3) remove restrictions on the ability of legislative caucus committees to make organization expenditures during primaries.

### APPROPRIATIONS

S.B. No. **1079** (RAISED) APPROPRIATIONS. 'AN ACT CONCERNING COMPETITIVENESS AND LABOR COSTS AT THE CONNECTICUT AIRPORT AUTHORITY', to allow certain employees of the Connecticut Airport Authority and require certain future employees of the authority to participate in retirement and benefit plans implemented by the authority.

S.B. No. **1080** (RAISED) APPROPRIATIONS. 'AN ACT CONCERNING VARIOUS REVISIONS TO THE TEACHERS' RETIREMENT SYSTEM', to revise and update the teachers' retirement system statutes to align with current practices.

S.B. No. **1081** (RAISED) APPROPRIATIONS. 'AN ACT CONCERNING THE INTEREST RATE RELATING TO TEACHERS' RETIREMENT SYSTEM COST-OF-LIVING ALLOWANCES AND RESERVING CERTAIN LOTTERY FUND REVENUE FOR THE CONNECTICUT TEACHERS' RETIREMENT FUND BONDS SPECIAL CAPITAL RESERVE FUND', to revise the interest rate relating to adjustments of cost-of-living allowances under the teachers' retirement system and reserve certain Lottery Fund revenue for payment to the Connecticut Teachers' Retirement Fund Bonds Special Capital Reserve Fund prior to transfer to the regionalization subaccount within the regional planning incentive account.

S.B. No. **1082** (RAISED) APPROPRIATIONS. 'AN ACT CONCERNING A RETIRED TEACHER ADVISORY COUNCIL, THE MEMBERSHIP OF AND TERM LIMITS FOR THE TEACHERS' RETIREMENT BOARD, A CAP ON CERTAIN PROFESSIONAL FEES PAID BY THE BOARD, AND MEDICARE SUPPLEMENTAL PLANS FOR RETIRED TEACHERS', to (1) establish a Retired Teacher Advisory Council for the Teachers' Retirement Board; (2) require that an additional retired teacher be added to the board's membership; (3) institute term limits for board members; (4) cap the amount of certain professional fees paid by the board; and (5) require that the board offer a Medicare supplemental plan to retired teachers.

H.B. No. **5088** (COMM) APPROPRIATIONS. 'AN ACT REQUIRING THE PAYMENT OF A REWARD TO PATRICIA "PIDGIE" D'ALLESSIO', to recognize and compensate Ms. Patricia "Pidgie" D'Allessio for her role in the identification, arrest and conviction of serial predator Robert

Nelson Malm, who sexually assaulted Ms. D'Allessio and sexually assaulted and murdered eleven-year-old Irene Fiederowicz.

H.B. No. **5607** (COMM) APPROPRIATIONS. 'AN ACT CONCERNING THE USE OF COVID-19 RELIEF FUNDS TO REPLENISH THE UNEMPLOYMENT COMPENSATION TRUST FUND', to require that a portion of COVID-19 relief funds be deposited into the Unemployment Compensation Trust Fund.

H.B. No. **5742** (COMM) APPROPRIATIONS. 'AN ACT CONCERNING THE USE OF COVID-19 RELIEF FUNDS FOR DOMESTIC VIOLENCE, MENTAL HEALTH, SUICIDE PREVENTION AND SUBSTANCE ABUSE SERVICE PROVIDERS', to require that a portion of COVID-19 relief funds be used to provide additional funding for domestic violence, mental health, suicide prevention and substance abuse services for persons suffering as a result of the COVID-19 pandemic.

H.B. No. **6659** (RAISED) APPROPRIATIONS. 'AN ACT CONCERNING THE ESTABLISHMENT OF THE CONNECTICUT BABY BOND TRUST', to establish the Connecticut Baby Bond Trust.

H.B. No. **6660** (RAISED) APPROPRIATIONS. 'AN ACT CONCERNING A STUDY OF LIENS PLACED ON PERSONAL PROPERTY FOR STATE RECOVERY OF FINANCIAL ASSISTANCE', to require the Department of Social Services to study the feasibility of establishing a prohibition on the placement of department liens on personal property, in addition to the prohibition on the placement of such liens on real property, except where required by federal law.

H.B. No. **6661** (RAISED) APPROPRIATIONS. 'AN ACT CONCERNING THE ESTABLISHMENT OF A FINANCIAL LITERACY TRUST FUND', to establish the Financial Literacy Trust Fund to be used by the Treasurer to promote and raise awareness of financial literacy to state residents.

'AN ACT DECLARING RACISM AS A PUBLIC HEALTH CRISIS AND ESTABLISHING THE COMMISSION ON RACIAL EQUITY IN PUBLIC HEALTH', to declare racism as a public health crisis, establish the Commission on Racial Equity in Public Health and require studies concerning the racial equity of various state programs related to such crisis.
