INTRODUCTION OF BILLS SENATE AND HOUSE BILLS AND RESOLUTIONS

GOVERNMENT ADMINISTRATION AND ELECTIONS

S.B. No. **1109** (RAISED) GOVERNMENT ADMINISTRATION AND ELECTIONS. 'AN ACT CONCERNING THE CONVEYANCE OF A PARCEL OF STATE LAND IN THE TOWN OF SOUTH WINDSOR', to convey a parcel of state land in the town of South Windsor to South Windsor for economic development purposes.

S.B. No. **1110** (RAISED) GOVERNMENT ADMINISTRATION AND ELECTIONS. 'AN ACT AMENDING THE CONVEYANCE OF PARCELS OF STATE LAND TO THE NEW HAVEN PORT AUTHORITY', to amend a prior conveyance to reduce the purchase price for parcels of state land by the cost of environmental testing and remediation of the parcel for contamination on the parcels.

S.B. No. **1111** (RAISED) GOVERNMENT ADMINISTRATION AND ELECTIONS. 'AN ACT AMENDING A CONVEYANCE OF A PARCEL OF STATE LAND IN THE TOWN OF FAIRFIELD', to amend a prior conveyance of a parcel of state land in the town of Fairfield to the town of Fairfield to change the purpose and permit the sale or lease of the parcel.

S.B. No. **1112** (RAISED) GOVERNMENT ADMINISTRATION AND ELECTIONS. 'AN ACT AMENDING THE CONVEYANCE OF PARCELS OF STATE LAND TO THE CITY OF NEW HAVEN', to amend the property description of parcels of state land conveyed to the city of New Haven for open space.

S.B. No. **1113** (RAISED) GOVERNMENT ADMINISTRATION AND ELECTIONS. 'AN ACT CONCERNING THE CONVEYANCE OF A PARCEL OF STATE LAND IN THE TOWN OF EAST WINDSOR AT 36 GARDNER STREET TO THE TOWN OF EAST WINDSOR', to convey a parcel of state land and any improvements on said parcel to the town of East Windsor for purposes of creating a municipal services complex.

S.B. No. **1114** (RAISED) GOVERNMENT ADMINISTRATION AND ELECTIONS. 'AN ACT RELINQUISHING THE STATE INTEREST IN A PARCEL OF LAND CONVEYED TO THE TOWN OF EAST WINDSOR', to remove a restriction that a parcel of land conveyed by the state to the town of East Windsor be used for low and moderate income housing or related activities.

S.B. No. **1115** (RAISED) GOVERNMENT ADMINISTRATION AND ELECTIONS. 'AN ACT CONCERNING THE CONVEYANCE OF A PARCEL OF STATE LAND IN THE TOWN OF SOMERS', to convey a parcel of state land in the town of Somers to the town of Somers for public safety purposes.

S.B. No. **1116** (RAISED) GOVERNMENT ADMINISTRATION AND ELECTIONS. 'AN ACT CONCERNING THE CONVEYANCE OF A PARCEL OF STATE LAND IN THE TOWN OF ROCKY HILL', to convey a parcel of state land in the town of Rocky Hill to the town of Rocky Hill for municipal purposes.

S.B. No. **1117** (RAISED) GOVERNMENT ADMINISTRATION AND ELECTIONS. 'AN ACT CONCERNING THE CONVEYANCE OF A PARCEL OF STATE LAND IN THE TOWN OF CHESHIRE', to convey a parcel of state land in the town of Cheshire to the town of Cheshire for a school bus depot.

H.B. No. **6676** (RAISED) GOVERNMENT ADMINISTRATION AND ELECTIONS. 'AN ACT CONCERNING THE REPEAL OF THE CONVEYANCE OF A PARCEL OF STATE LAND TO THE TOWN OF FARMINGTON', to repeal a prior authorization for a conveyance of a parcel of state land in the town of Farmington to the town of Farmington.

H.B. No. **6677** (RAISED) GOVERNMENT ADMINISTRATION AND ELECTIONS. 'AN ACT AMENDING THE CONVEYANCE OF A PARCEL OF STATE LAND IN THE CITY OF HARTFORD AT 75 ELM STREET', to amend a prior conveyance of a parcel of state land to the Capital Region Development Authority to permit the parcel to also be used for housing and economic development purposes.

H.B. No. **6680** (RAISED) GOVERNMENT ADMINISTRATION AND ELECTIONS. 'AN ACT CONCERNING THE CONVEYANCE OF A PARCEL OF STATE LAND IN THE TOWN OF WINDSOR TO THE TOWN OF WINDSOR', to convey a parcel of state land to the town of Windsor for economic and transit-oriented development purposes.

H.B. No. **6681** (RAISED) GOVERNMENT ADMINISTRATION AND ELECTIONS. 'AN ACT CONCERNING THE CONVEYANCE OF A PARCEL OF STATE LAND IN THE CITY OF HARTFORD AT 340 CAPITOL AVENUE TO THE CAPITAL REGION DEVELOPMENT AUTHORITY', to convey a parcel of state land in the city of Hartford to the Capital Region Development Authority for housing and economic development purposes.

H.B. No. **6682** (RAISED) GOVERNMENT ADMINISTRATION AND ELECTIONS. 'AN ACT CONCERNING THE CONVEYANCE OF A PARCEL OF STATE LAND IN THE CITY OF HARTFORD AT 30 TRINITY STREET TO THE CAPITAL REGION DEVELOPMENT AUTHORITY', to convey a parcel of state land in the city of Hartford to the Capital Region Development Authority for housing and economic development purposes.

H.B. No. **6683** (RAISED) GOVERNMENT ADMINISTRATION AND ELECTIONS. 'AN ACT CONCERNING THE CONVEYANCE OF A PARCEL OF STATE LAND IN THE CITY OF HARTFORD AT 18 TO 20 TRINITY STREET TO THE CAPITAL REGION DEVELOPMENT AUTHORITY', to convey a parcel of state land in the city of Hartford to the Capital Region Development Authority for housing and economic development purposes.
