## AN ACT CONCERNING INSTALLERS OF RESIDENTIAL VERTICAL PLATFORM LIFTS.

Be it enacted by the Senate and House of Representatives in General Assembly convened:

- Section 1. Section 20-340f of the general statutes is repealed and the
- 2 following is substituted in lieu thereof (*Effective from passage*):
- 3 (a) Not later than December 31, 2016, the Commissioner of Consumer
- 4 Protection, after consultation with the Elevator Installation, Repair and
- 5 Maintenance Board established pursuant to section 20-331, shall adopt
- 6 regulations, in accordance with the provisions of chapter 54, to establish
- a residential stair lift technician's license. Not later than December 31,
- 8 2022, the commissioner, after consultation with the Elevator Installation,
- 9 Repair and Maintenance Board, shall amend such regulations to
- 10 <u>establish a residential vertical platform lift technician's license.</u> Such
- 11 regulations shall include, but need not be limited to, the amount and
- 12 type of experience, training, continuing education and examination
- 13 requirements, if any, for a person to obtain and renew [such] a
- 14 <u>residential stair lift technician's license and a residential vertical</u>

- 15 platform lift technician's license.
- 16 (b) The initial fee for a residential stair lift technician's license <u>or a</u> 17 <u>residential vertical platform lift technician's license</u> shall be one hundred
- 18 fifty dollars and the renewal fee for each such license shall be seventy-
- 19 five dollars. Licenses shall be valid for a period of one year from the date
- of issuance.
- 21 (c) Nothing in this section shall prohibit the holder of an occupational
- license issued pursuant to this chapter that allows the installation and repair of residential stair lifts or residential vertical platform lifts from
- repair of residential stair lifts <u>or residential vertical platform lifts</u> from performing such work. A holder of such occupational license shall not
- 25 be required to obtain a residential stair lift technician's license or a
- 26 residential vertical platform lift technician's license.

#### Explanation

The bill establishes a residential vertical platform lift technicians license within the Department of Consumer Protection resulting in a potential revenue gain of less than \$1,000 to the extent this new license is applied for. The initial license has a fee of \$150 and an annual renewal fee of \$75.

#### The Out Years

The annualized ongoing fiscal impact identified above would continue into the future subject to the number of licenses applied for.

# AN ACT CONCERNING INSTALLERS OF RESIDENTIAL VERTICAL PLATFORM LIFTS.

#### **SUMMARY**

This bill establishes a residential vertical platform lift technician's license. The license is valid for one year from the issue date. The initial license fee is \$150 and the renewal fee is \$75.

By December 31, 2022, the consumer protection commissioner, after consulting with the Elevator Installation, Repair and Maintenance Board, must amend existing residential stair lift technician regulations to establish the license (Conn. Agencies Regs. § 21a-340f-1 et seq.). The regulations must include the amount and type of experience, training, continuing education, and exam requirements, if any, needed to obtain or renew the license. These same provisions apply under existing law to the residential stair list technician's license.

Under the bill, licensed tradespeople whose licenses allow them to install and repair residential vertical platform lifts (e.g., unlimited elevator contractors) may continue to do so and are not required to obtain a residential vertical platform lift technician's license.
