***AN ACT CONCERNING RETIREE MEMBERS OF THE TEACHERS'
RETIREMENT BOARD.***

Be it enacted by the Senate and House of Representatives in General Assembly convened:

1 Section 1. Subsection (a) of section 10-183l of the general statutes is
2 repealed and the following is substituted in lieu thereof (*Effective from*
3 *passage*):

4 (a) (1) On and after July 1, 1991, the management of the system shall
5 continue to be vested in the Teachers' Retirement Board, whose
6 members shall include the Treasurer, the Secretary of the Office of Policy
7 and Management and the Commissioner of Education, or their
8 designees, who shall be voting members of the board, ex officio. (2) On
9 or before June 15, 1985, and quadrennially thereafter, the members of
10 the system shall elect from their number, in a manner prescribed by said
11 board, two persons to serve as members of said board for terms of four
12 years beginning July first following such election. Both of such persons
13 shall be active teachers who shall be nominated by the members of the

14 system who are not retired and elected by all the members of the system.
15 On or before July 1, 1991, and quadrennially thereafter, the members of
16 the system shall elect from their number, in a manner prescribed by said
17 board, three persons to serve as members of said board for terms of four
18 years beginning July first following such election. Two of such persons
19 shall be retired teachers who shall be nominated by the retired members
20 of the system and elected by all the members of the system and one shall
21 be an active teacher who shall be nominated by the members of the
22 system who are not retired and elected by all the members of the system.
23 (3) On or before July 1, 2011, and quadrennially thereafter, the members
24 of the system shall elect from their number, in a manner prescribed by
25 said board, one person to serve as a member of said board for a term of
26 four years beginning July first following such election. Such person shall
27 be an active teacher who shall be nominated by the members of the
28 system who are not retired, elected by all the members of the system
29 and a member of an exclusive representative of a teachers' bargaining
30 unit that is not represented by the members of the board elected under
31 subdivision (2) of this subsection. (4) On or before October 1, 2023, and
32 quadrennially thereafter, the retired members of the system shall elect
33 from their number, in a manner prescribed by said board, two persons
34 to serve as members of said board for a term of four years beginning
35 October first following such election. Both of such persons shall be (A)
36 retired teachers who are receiving a pension benefit from the system,
37 and (B) nominated and elected by the members of the system who are
38 retired. (5) If a vacancy occurs in the positions filled by the members of
39 the system who are not retired, said board shall elect a member of the
40 system who is not retired to fill the unexpired portion of the term. If a
41 vacancy occurs in the positions filled by the retired members of the
42 system, said board shall elect a retired member of the system to fill the
43 unexpired portion of the term. The Governor shall appoint five public
44 members to said board in accordance with the provisions of section 4-
45 9a, one of whom shall be the mayor, first selectman or chief elected
46 official of a municipality. On and after October 31, 2017, the Governor
47 shall fill the next vacant position on the board that is appointed by the
48 Governor with a person who is the mayor, first selectman or chief

49 elected official of a municipality. The members of the board shall serve
50 without compensation, but shall be reimbursed for any expenditures or
51 loss of salary or wages which they incur through service on the board.
52 A majority of the membership of the board shall constitute a quorum for
53 the transaction of any business.

This act shall take effect as follows and shall amend the following sections:

Explanation

The bill, which requires the election of two additional retiree members of the Teachers' Retirement Board (TRB), will result in election costs to the TRB of approximately \$51,000 in FY 24.

House "A" changes the months from July to October as does not have a fiscal impact.

OFA Bill Analysis**HB 6489 (as amended by House "A")******AN ACT CONCERNING RETIREE MEMBERS OF THE TEACHERS' RETIREMENT BOARD.*****SUMMARY:**

The bill adds two persons to serve as members of the Teachers' Retirement Board (TRB) for a four-year term. Both the persons must be retired teachers who are receiving pensions from the Teachers' Retirement System (TRS). They must also be nominated and elected only by members of the TRS who are also retired.

House Amendment "A" changes the months from July to October.

EFFECTIVE DATE: Upon Passage

BACKGROUND***Teachers' Retirement Board Membership***

Current law provides for 14 members of the Teachers' Retirement Board as follows: (1) four active members (nominated by active members and voted on by all members), (2) two retired members (nominated by retired members and voted on by all members), (3) three ex officio members (State Treasurer, Secretary of the Office of Policy and Management, and Commissioner of Education or their designees) and (4) five public members appointed by the Governor (one public member must be a mayor, first selectman or chief elected official of a municipality). The elected and appointed members of the TRB serve a term of four years.
