**AN ACT APPROPRIATING FUNDS FOR CERTAIN HOMELESSNESS
RESPONSE PROGRAMS.**

Be it enacted by the Senate and House of Representatives in General
Assembly convened:

1 Section 1. (*Effective July 1, 2023*) The sum of twenty-eight million one
2 hundred fifty-five thousand three hundred twenty-six dollars is
3 appropriated to the Department of Housing from the General Fund,
4 for the fiscal year ending June 30, 2024, for housing and homeless
5 services.

6 Sec. 2. (*Effective July 1, 2023*) The sum of nine hundred sixty-seven
7 thousand three hundred seventy-three dollars is appropriated to the
8 Department of Housing from the General Fund, for the fiscal year
9 ending June 30, 2024, for homeless youth.

10 Sec. 3. (*Effective July 1, 2023*) The sum of two hundred nine thousand
11 nine hundred fifty-four dollars is appropriated to the Department of
12 Housing from the General Fund, for the fiscal year ending June 30,
13 2024, for municipal housing and homeless services.

14 Sec. 4. (*Effective July 1, 2023*) The sum of seven million seven
15 hundred thirteen thousand seven hundred ninety-nine dollars is

16 appropriated to the Department of Mental Health and Addiction
17 Services from the General Fund, for the fiscal year ending June 30,
18 2024, for housing supports and services.

19 Sec. 5. (*Effective July 1, 2023*) The sum of five million nine hundred
20 ninety-five thousand dollars is appropriated to the Department of
21 Housing from the General Fund, for the fiscal years ending June 30,
22 2024, and June 30, 2025, for housing and homeless services related to
23 the Coordinated Access Network.

24 Sec. 6. (*Effective July 1, 2023*) The sum of five million dollars is
25 appropriated to the Department of Housing from the General Fund,
26 for the fiscal years ending June 30, 2024, and June 30, 2025, for housing
27 and homeless services related to cold weather emergency responses.

28 Sec. 7. (*Effective July 1, 2023*) The sum of two million dollars is
29 appropriated to the Department of Housing from the General Fund,
30 for the fiscal years ending June 30, 2024, and June 30, 2025, for housing
31 and homeless services related to the flexible funding subsidy pool.

This act shall take effect as follows and shall amend the following sections:
