***AN ACT CONCERNING THE OVERSIGHT OF HEALTH CARE IN
CORRECTIONAL INSTITUTIONS BY THE DEPARTMENT OF PUBLIC
HEALTH.***

Be it enacted by the Senate and House of Representatives in General Assembly convened:

1 Section 1. (NEW) (*Effective July 1, 2023*) (a) Not later than January 1,
2 2024, there shall be established within the Department of Public Health
3 an Office of Oversight of Health Care in Correctional Institutions. The
4 office shall be responsible for oversight of the delivery of health care
5 services to inmates in correctional institutions, including, but not
6 limited to: (1) Ensuring that the Commissioner of Correction
7 implements the plan for the provision of health care services to
8 inmates developed pursuant to section 18-81pp of the general statutes;
9 (2) establishing guidelines for the delivery of health care services to
10 inmates; (3) conducting periodic inspections of correctional institutions
11 to ensure that the delivery of health care services to inmates is
12 adequate and safe; (4) recommending any necessary changes or
13 improvements to the delivery of health care services to inmates; (5)
14 issuing notice to a correctional institution of any failure on the part of
15 the correctional institution to deliver adequate or safe health care
16 services; and (6) ordering corrective action to a correctional institution

17 that was issued a notice pursuant to subdivision (5) of this subsection.

18 (b) Not later than January 1, 2025, the Office of Oversight of Health
19 Care in Correctional Institutions shall, in consultation with the
20 Department of Mental Health and Addiction Services, develop a
21 model plan setting forth requirements concerning the delivery of
22 quality health care services to inmates by the Department of
23 Correction.

24 (c) Not later than January 1, 2025, and annually thereafter, the Office
25 of Oversight of Health Care in Correctional Institutions shall report, in
26 accordance with the provisions of section 11-4a of the general statutes,
27 to the joint standing committees of the General Assembly having
28 cognizance of matters relating to public health and the judiciary
29 regarding (1) the adequacy and safety of the delivery of health care
30 services to inmates by the Department of Correction, (2) the
31 development of the model plan pursuant to subsection (b) of this
32 section and implementation of such plan by the Department of
33 Correction, (3) the findings of each inspection of a correctional facility
34 performed pursuant to subsection (a) of this section, and (4)
35 recommendations for any legislation necessary to improve the delivery
36 of quality health care services to inmates.

This act shall take effect as follows and shall amend the following sections:
