**"AN ACT CONCERNING THE STATE BUDGET FOR THE BIENNIUM  
ENDING JUNE 30, 2025, AND MAKING APPROPRIATIONS  
THEREFOR, AND PROVISIONS RELATED TO REVENUE AND  
OTHER ITEMS IMPLEMENTING THE STATE BUDGET."**

1 After the last section, add the following and renumber sections and  
2 internal references accordingly:

3 "Sec. 501. (*Effective July 1, 2023*) The sum of \$200,000 of the amount  
4 appropriated in section 1 of this act to the Department of Education, for  
5 Charter Schools, for the fiscal year ending June 30, 2024, shall be made  
6 available in said fiscal year to provide a grant-in-aid to the governing  
7 authority of the Danbury Charter School, located in the town of

8 Danbury and granted an initial certificate of approval for a charter on  
 9 October 3, 2018, by the State Board of Education pursuant to section 10-  
 10 66bb of the general statutes, for the purpose of commencing operations  
 11 of such charter school. For purposes of subdivision (2) of subsection (a)  
 12 of section 10-66bb of the general statutes, such initial certificate of  
 13 approval for a charter shall be deemed a charter as of July 1, 2023.

14 Sec. 502. (*Effective July 1, 2024*) The sum of \$1,320,000 of the amount  
 15 appropriated in section 1 of this act to the Department of Education, for  
 16 Charter Schools, for the fiscal year ending June 30, 2025, shall be made  
 17 available in said fiscal year to provide a grant-in-aid to the governing  
 18 authority of the Danbury Charter School, located in the town of  
 19 Danbury and granted an initial certificate of approval for a charter on  
 20 October 3, 2018, by the State Board of Education pursuant to section 10-  
 21 66bb of the general statutes, for the purpose of operating such charter  
 22 school."

This act shall take effect as follows and shall amend the following sections:
