Title: AN ACT PREVENTING AN ADVERSE ACTION AGAINST A HEALTH CARE PROVIDER DUE TO AN ADVERSE ACTION TAKEN BY ANOTHER STATE AS A RESULT OF SUCH PROVIDER'S INVOLVEMENT IN PROVIDING REPRODUCTIVE HEALTH CARE SERVICES.

Statement of Purpose: To prevent (1) the Commissioners of Public Health and Consumer Protection, (2) health care institutions, and (3) medical malpractice insurers from taking any adverse action against a health care provider due to an adverse action taken by another state as a result of such provider's provision of reproductive health care services.
