Title: AN ACT EXPANDING MEMBERSHIP OF THE POLICE OFFICER STANDARDS AND TRAINING COUNCIL.

Statement of Purpose: To (1) expand membership of the Police Officer Standards and Training Council, (2) revise the process to appeal a suspension, cancellation or revocation of certification by the council, (3) require guidelines on police interactions with the public without the use of body-worn recording equipment, and (4) require a report regarding police officer conduct that undermines public confidence in law enforcement.
