Title: AN ACT CONCERNING FAITHLESS PRESIDENTIAL ELECTORS AND AUTHORIZING MANDAMUS ACTIONS RELATED TO THE CERTIFICATION OR DECLARATION OF ELECTION RESULTS.

Statement of Purpose: To (1) nullify the vote of, remove, replace and impose certain penalties upon faithless presidential electors, and (2) allow for mandamus actions to be brought in the Supreme Court to compel certain officers to comply with laws relating to certification or declaration of election results.
