**Title:** AN ACT CONCERNING THE DEPARTMENT OF ECONOMIC AND COMMUNITY DEVELOPMENT'S RECOMMENDATIONS REGARDING THE JOBSCT TAX REBATE PROGRAM AND CERTAIN AEROSPACE MANUFACTURING PROJECTS.

**Statement of Purpose:** To (1) replace provisions requiring a contract under the JobsCT tax rebate program with provisions requiring a rebate allocation notice, and (2) extend the time period an eligible taxpayer may utilize certain aerospace manufacturing project tax benefits earned under certain assistance agreements.
