Title: AN ACT AUTHORIZING CERTAIN KILLING OF BLACK BEAR AND PROHIBITING INTENTIONAL FEEDING OF POTENTIALLY DANGEROUS ANIMALS.

Statement of Purpose: To establish permits for the taking of bear that damage crops, livestock or bees, authorize the killing of bears that cause harm to a person or pet or that enter an occupied building, provide for an annual bear hunt season in Litchfield County by lottery and prohibit the intentional and unintentional feeding of potentially dangerous animals.
