**Title:** AN ACT CONCERNING REGIONAL ELECTION ADVISORS AND A TASK FORCE ON ELECTION ADMINISTRATION IN MUNICIPALITIES.

**Statement of Purpose:** To (1) rename "regional election monitors" as "regional election advisors", (2) provide that a regional council of governments, or a combination of regional councils of governments and individual municipalities, may appoint regional election advisors for assistance with the performance of election administration duties, (3) provide for an annual grant to regional councils of governments that appoint a regional election advisor, and (4) establish a task force to study means of ensuring election administration in municipalities is fully staffed by properly trained election officials.
