"AN ACT CONCERNING JUVENILE JUSTICE."

1 Strike subsection (b) of section 3 in its entirety and substitute the
2 following in lieu thereof:

3 "(b) The committee shall consist of the following members:

4 (1) Two members of the General Assembly, one of whom shall be
5 appointed by the speaker of the House of Representatives, and one of
6 whom shall be appointed by the president pro tempore of the Senate;

7 (2) The chairpersons and ranking members of the joint standing
8 committees of the General Assembly having cognizance of matters
9 relating to the judiciary, children, human services and appropriations,
10 or their designees;

11 (3) The Chief Court Administrator, or the Chief Court
12 Administrator's designee;

13 (4) A judge of the superior court for juvenile matters, appointed by
14 the Chief Justice;

15 (5) The executive director of the Court Support Services Division of
16 the Judicial Department, or the executive director's designee;

17 (6) The executive director of the Superior Court Operations Division,
18 or the executive director's designee;

19 (7) The Chief Public Defender, or the Chief Public Defender's
20 designee;

21 (8) The Chief State's Attorney, or the Chief State's Attorney's
22 designee;

23 (9) The Commissioner of Children and Families, or the
24 commissioner's designee;

25 (10) The Commissioner of Correction, or the commissioner's
26 designee;

27 (11) The Commissioner of Education, or the commissioner's designee;

28 (12) The Commissioner of Mental Health and Addiction Services, or
29 the commissioner's designee;

30 (13) The Labor Commissioner, or the commissioner's designee;

31 (14) The Commissioner of Social Services, or the commissioner's
32 designee;

33 (15) The Commissioner of Public Health, or the commissioner's
34 designee;

35 (16) The president of the Connecticut Police Chiefs Association, or the
36 president's designee;

37 (17) The chief of police of a municipality with a population in excess
38 of one hundred thousand, appointed by the president of the Connecticut

39 Police Chiefs Association;

40 (18) The chief of police of a municipality with a population of less
41 than fifty thousand, appointed by the president of the Connecticut
42 Police Chiefs Association;

43 ~~[(18)]~~ (19) Two child or youth advocates, one of whom shall be
44 appointed by one chairperson of the Juvenile Justice Policy and
45 Oversight Committee, and one of whom shall be appointed by the other
46 chairperson of the Juvenile Justice Policy and Oversight Committee;

47 ~~[(19)]~~ (20) Two parents or parent advocates, at least one of whom is
48 the parent of a child who has been involved with the juvenile justice
49 system, one of whom shall be appointed by the minority leader of the
50 House of Representatives, and one of whom shall be appointed by the
51 minority leader of the Senate;

52 ~~[(20)]~~ (21) The Victim Advocate, or the Victim Advocate's designee;

53 ~~[(21)]~~ (22) The Child Advocate, or the Child Advocate's designee;
54 [and]

55 ~~[(22)]~~ (23) The Secretary of the Office of Policy and Management, or
56 the secretary's designee;

57 (24) Two children, youths or young adults under twenty-six years of
58 age with lived experience in the juvenile justice system, nominated by
59 the community expertise subcommittee, one of whom shall be
60 appointed by each chairperson of this committee;

61 (25) One community member who may be a family member of a child
62 who has been involved with the juvenile justice system or a credible
63 messenger with lived experience in the juvenile justice system and who
64 works with youth in the juvenile justice system, nominated by the
65 community expertise subcommittee and appointed by the chairpersons
66 of this committee;

67 (26) One member of the Mashantucket Pequot Tribe, appointed by

68 the tribe; and

69 (27) One member of the Mohegan Tribe of Indians of Connecticut,

70 appointed by the tribe."
