Substitute House Bill No. 5482

*House of Representatives, April 3, 2024*

The Committee on Public Safety and Security reported through REP. BOYD of the 50th Dist., Chairperson of the Committee on the part of the House, that the substitute bill ought to pass.

***AN ACT AUTHORIZING BONDS OF THE STATE FOR THE CONSTRUCTION OF A NEW BARRACKS FOR TROOP D OF THE DIVISION OF STATE POLICE IN DANIELSON.***

Be it enacted by the Senate and House of Representatives in General Assembly convened:

1 Section 1. Section 20 of public act 23-205 is amended to read as follows  
2 (*Effective July 1, 2024*):

3 The State Bond Commission shall have power, in accordance with the  
4 provisions of this section and sections 21 to 26, inclusive, of [this act]  
5 public act 23-205, from time to time to authorize the issuance of bonds  
6 of the state in one or more series and in principal amounts in the  
7 aggregate not exceeding [~~\$520,345,000~~] \$540,345,000.

8 Sec. 2. Subsection (c) of section 21 of public act 23-205 is amended to  
9 read as follows (*Effective July 1, 2024*):

10 (c) For the Department of Emergency Services and Public Protection:

11 (1) Alterations, renovations and improvements to buildings and

12 grounds, including utilities, mechanical systems and energy  
13 conservation projects, not exceeding \$31,500,000;

14 (2) Construction of a new barracks for Troop D of the Division of State  
15 Police in Danielson, not exceeding \$20,000,000.

This act shall take effect as follows and shall amend the following sections:		
Section 1	July 1, 2024	PA 23-205, Sec. 20
Sec. 2	July 1, 2024	PA 23-205, Sec. 21(c)

**Explanation**

The bill authorizes \$20 million in General Obligation bonds for the construction of a new barracks for Troop D of the Division of State Police in Danielson. To the extent bonds are fully allocated and expended, total debt service is expected to be approximately \$28.6 million over the 20-year duration of the bonds, with annual payments starting no earlier than FY 26.

**The Out Years**

The annualized ongoing fiscal impact identified above would continue into the future subject to the terms of any bonds issued.

***AN ACT AUTHORIZING BONDS OF THE STATE FOR THE CONSTRUCTION OF A NEW BARRACKS FOR TROOP D OF THE DIVISION OF STATE POLICE IN DANIELSON.***

**SUMMARY**

This bill authorizes \$20 million in new state general obligation bonds in FY 25 to the Department of Emergency Services and Public Protection for constructing a new barracks for the State Police Troop D in Danielson. By law, the bonds are subject to standard issuance procedures and have a maximum term of 20 years.
