The Committee on General Law reported through SEN. MARONEY of the 14th Dist., Chairperson of the Committee on the part of the Senate, that the bill ought to pass.

## AN ACT ESTABLISHING A TASK FORCE TO STUDY CONSUMER PROTECTION MEASURES.

Be it enacted by the Senate and House of Representatives in General Assembly convened:

- 1 Section 1. (*Effective from passage*) (a) There is established a task force
- 2 to study consumer protection measures in this state.
- 3 (b) The task force shall consist of the following members:
- 4 (1) Two appointed by the speaker of the House of Representatives;
- 5 (2) Two appointed by the president pro tempore of the Senate;
- 6 (3) One appointed by the majority leader of the House of
- 7 Representatives;
- 8 (4) One appointed by the majority leader of the Senate;
- 9 (5) One appointed by the minority leader of the House of
- 10 Representatives;
- 11 (6) One appointed by the minority leader of the Senate;

12 (7) The Commissioner of Consumer Protection, or the commissioner's designee; and

- 14 (8) Two persons appointed by the Governor.
- 15 (c) Any member of the task force appointed under subdivision (1),
- 16 (2), (3), (4), (5) or (6) of subsection (b) of this section may be a member
- 17 of the General Assembly.
- (d) All initial appointments to the task force shall be made not later
- 19 than thirty days after the effective date of this section. Any vacancy shall
- 20 be filled by the appointing authority.
- 21 (e) The speaker of the House of Representatives and the president pro
- 22 tempore of the Senate shall select the chairpersons of the task force from
- among the members of the task force. Such chairpersons shall schedule
- 24 the first meeting of the task force, which shall be held not later than sixty
- 25 days after the effective date of this section.
- 26 (f) The administrative staff of the joint standing committee of the
- 27 General Assembly having cognizance of matters relating to consumer
- 28 protection shall serve as administrative staff of the task force.
- 29 (g) Not later than January 1, 2025, the task force shall submit a report
- on its findings and recommendations to the joint standing committee of
- 31 the General Assembly having cognizance of matters relating to
- 32 consumer protection, in accordance with the provisions of section 11-4a
- of the general statutes. The task force shall terminate on the date that it
- 34 submits such report or January 1, 2025, whichever is later.

This act shall take effect as follows and shall amend the following sections:
