**Title:** AN ACT REVISING MOTOR VEHICLE STATUTES CONCERNING TOWING OCCUPIED VEHICLES AND THE OPERATION AND INSPECTION OF SCHOOL BUSES.

**Statement of Purpose:** To (1) prohibit the towing of occupied vehicles, (2) increase the penalty regarding the improper use of a motor vehicle registration, (3) provide guidance to school bus owners or operators regarding the daily inspection of a school bus, and (4) make a technical revision to a motor vehicle statute.
