Substitute Senate Bill No. 1379

Senate, April 23, 2025

The Committee on Judiciary reported through SEN. WINFIELD of the 10th Dist., Chairperson of the Committee on the part of the Senate, that the substitute bill ought to pass.

AN ACT CONFIRMING AND ADOPTING VOLUMES 1 TO 13, INCLUSIVE, OF THE GENERAL STATUTES REVISED TO JANUARY 1, 2025.

Be it enacted by the Senate and House of Representatives in General Assembly convened:

1 Section 1. (NEW) (*Effective from passage*) Volumes 1 to 13, inclusive, of
2 the general statutes of Connecticut, revised to 1958, consolidated,
3 codified, arranged and revised to January 1, 2025, by the legislative
4 commissioners under the provisions of subsection (g) of section 2-56 of
5 the general statutes and published under the title "The General Statutes
6 of Connecticut, Revision of 1958, Revised to January 1, 2025", including
7 the consolidation, codification, arrangement and revision of the public
8 acts of the state from 1959 to 2024, inclusive, are adopted, ratified,
9 confirmed and enacted.

This act shall take effect as follows and shall amend the following sections:
