The Committee on Judiciary reported through SEN. WINFIELD of the 10th Dist., Chairperson of the Committee on the part of the Senate, that the joint resolution ought to be adopted.

RESOLUTION ACCEPTING THE RECOMMENDATION OF THE CLAIMS COMMISSIONER TO MAKE PAYMENT IN EXCESS OF THIRTY-FIVE THOUSAND DOLLARS WITH RESPECT TO THE CLAIM AGAINST THE STATE OF KALLMAN, MCKINNELL AND WOOD, ARCHITECTS, INC.

Resolved by this Assembly:

1 That the recommendation of the Claims Commissioner, file number
2 27513 of said commissioner, that an award of \$106,568.64, payable from
3 the appropriation to the adjudicated claims account of the General
4 Fund, be granted to Kallman, McKinnell and Wood, Architects, Inc., on
5 such claim against the state, is accepted and that payment of said
6 amount to said claimant is ordered.
