Title: AN ACT CONCERNING SENTENCE REDUCTION OR RELIEF FOR SURVIVORS OF DOMESTIC VIOLENCE, SEXUAL ASSAULT, STALKING OR HUMAN TRAFFICKING.

Statement of Purpose: To permit survivors of domestic violence, sexual assault, stalking or trafficking in persons for whom violence or abuse suffered by such survivors was a contributing factor influencing such survivor to commit an offense to be eligible for a sentence reduction or relief.
