

**Testimony for Task Force Meeting

**Its all about the money and not about the best interest of our children and families.**

**My name is Andrea Cota Eigner from Cromwell, Ct., mother of Justin Charles Eigner.**

**I am a member of We the People and many other organizations that fight for the rights of Families and our U.S. Constitution.**

**I have not seen my son in a year and a half, due to Susan Cousineau's fraudulent acts, who has the nerve to sit here on the task force, we the people designed, to rid the family court of criminals like her. She is the ring leader of all deceptions and evil greedy routine play acts. She is the devil in disguise, a statement one of my family members uses often to describe her.**

**I have been dragged through the Middletown corrupt family court system, (funded by the AFCC, a nationwide child trafficking group), since September 2008 when my son was legally kidnapped by his father, who no longer wanted to pay child support, with the assistance and abetting of court employees and other business people who are only interested in taking money and assets from parents and children. To name a few, Susan Cousineau, Judge Gerard Adelman, both AFCC members. Judge Harry Calmar, Dr. Donald Heibel, AMPS, Dr. Black-who deceased a year ago from a sudden heart attack, he also trafficked our children and threw them into the hands of abusers. All of whom have been hired by Susan Cousineau, who makes sure everyone gets paid well, while destroying children and their families.**

**I'll never forget the most traumatic day on October 6<sup>th</sup> 2008, 5 years ago, when Susan Cousineau interrogated and threatened me for 4 hours in a small side room in the court hall regarding my religious beliefs as a Catholic, when she told me I would never see my son again, and if I did not sign physical custody over to my ex. Mr. Eigner, she would put me away somewhere and drug me until I did. Sickened and worried about my son whom I hadn't seen in weeks, I signed him over thinking I would find a way to get him home soon, not knowing how corrupt at the time the family court system is. Another day in the court, two men in suits got off the elevator near the coffee shop, one saying to the other, "If you give Sue Cousineau 12 to 15 k she'll do whatever you want."**

**With Cousineau and Dornfield on the task force we will not be able to get access to the billing records, because they know they will be punished for their wicked money crimes. They need to be ordered to step down immediately. Their greed is unchanging.**

**I have done auditing along with many others on bills forced upon parents. After talking to many parent victims regarding their experiences with Susan Cousineau they revealed they are traumatized by her actions in the taking of their children and her over billing them by 6 to 12 times the allotted hourly rate of \$50 per hour, according to the office of the public defender. I have a sample of my long bills here, proving her over billing for exaggerated services in which she created to keep her money ring going. I also have an audit report here proving her zealous greed and horrific stealings from victim families who she preys upon with her child trafficking and racketeering business.**

**Its all about the money not about the best interest of our children and families.**

**Ms. Cousineau has not met with my son Justin more then once in 5 years, he did not even know who she was when I asked him several times about her a couple years ago. She did not return any of my calls in the past, but two of them. Ms. Cousineau does not care about the well being of my son, and is only concerned with filling her pockets with cash.**

**Attached is transcript from Aug. 12, 2013, see cover page, and pages 1 and 8, where Ms. Cousineau states she is Former GAL, and then lies in court on the record Dec. 23<sup>rd</sup> 2013 stating she never said that she was no longer on the case. She even told me so herself in the court hall, she was no longer on the case. She plays the role whenever she feels it suits her, but yet never does her proper job as a GAL.**

**She illegally arranged for Judge Adelman to try and overturn a Federal Judges decision of my debts to her which were dismissed in bankruptcy court, in which the Federal bankruptcy court had full knowledge of her assistance and abetting in the legal kidnapping of my son Justin, which did not justify her corrupt bills to me of \$6,000. She also threatened my home equity.**

**Susan Cousineau and other GAL's and their cronies, attack parents with threats, interrogations, religion, work schedules, just about anything they can conjure up in order to continue their money referral system. They intentionally cause disastrous disagreements between the parents to enable them to keep coming back to the courts to fight over the children, so they can collect more money.**

**After confronting one of the Judges in my case in a closed courtroom, saying to him, I know what is going on in here, you people lie cheat and steal to make money off my child. The judge replied, if you know whats going on and what we are doing, then why come in here wasting everyone's time... All of this of course was stricken from transcripts. Another day in court Susan Cousineau threw at me, my letters of good character friends family and professionals wrote and signed on my behalf, some of whom testified too... Cousineau stated, you could have signed them all. Imagine this dirty rat accusing me of signing a stack of goodwill letters from my loved ones. Behind bars is where criminals like her belong where she can repent for the rest of her life for the lives she took away from so many children and parents...**

**Family courts need to be abolished and criminals kept away from innocent victims. The corrupt AFCC needs to be shut down entirely.**



The undersigned guardian ad litem for the subject minor child respectfully avers the following:


1. She is the guardian ad litem for the subject minor child.


AFFIDAVIT OF FEES


