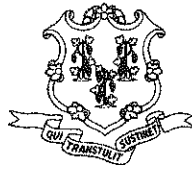

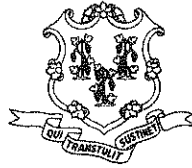
The agency fiscal note included a statement that municipalities would see an increase in sales tax revenue due to retail sales of medical marijuana being subject to the state sales tax. It should be noted that PA 13-184 eliminated the Municipal Revenue Sharing Account as of July 1, 2013 therefore there would be no municipal revenue gain related to sales tax. Previous to the act, 0.1% of the state's 6.35% sales tax was deposited in the account and distributed by formula to municipalities.
