Speakers will be limited to three minutes of testimony. Please submit 30 copies of written testimony at the time of sign-up, but not later than 2:00 P.M. The Committee requests that testimony be limited to matters related to the items on the Agenda. All public hearing testimony, written & spoken, is public information. The Committee encourages witnesses to submit a written statement and to condense oral testimony to a summary of that statement.
