(CSSD)**

The project goal is to make available a child's school record from the CSDE's data warehouse to Juvenile Probation Officers in a timely manner.

Effective June 22, 2016, Juvenile Probation Officers have access to a School Summary Report for clients with:

- an open case with Juvenile Probation,
- a Release of Information signed by the Parent/Guardian, AND
- a valid SASID # (10 digits).

This report allows Juvenile Probation Officers to view historical data available in the Connecticut State Department of Education data warehouse. Information from this warehouse is collected from public schools at certain time intervals throughout the school year.

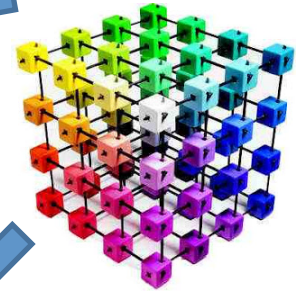
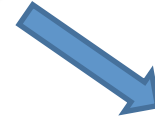
