Instructions to Requesting Police Officer

1. Complete the demographic and arrest information related to the Order to Detain (JD-JM-190).
2. During regular business hours, notify the local Juvenile Probation Supervisor of the request for information, and e-mail the JD-JM-218 for completion by Juvenile Probation.
3. During off-hours, notify and e-mail the JD-JM-218 to the designated Juvenile Detention/Residential Center for completion by the designated Juvenile Probation Services staff.
4. Submit the completed JD-JM-218 and JD-JM-190 to the Judge.

Instructions to Juvenile Probation Services

1. During regular business hours, obtain the JD-JM-218 from the Requesting Police Officer, and verify the request for information section.
2. During off-hours, obtain the JD-JM-218 from the designated Juvenile Detention/Residential Center, and verify the request for information section.
3. Complete the court information section, e-mail the completed JD-JM-218 to the Requesting Police Officer, and retain a copy of the completed JD-JM-218.

Instructions to Juvenile Residential Services NOTE: This section applies to off-hours requests only

1. Upon notification by a police officer of a request for information, provide the officer with the designated Juvenile Detention/Residential Center e-mail address to submit the JD-JM-218.
2. Notify Juvenile Probation Services of the request for information and e-mail the JD-JM-218 to the designated Juvenile Probation Services staff.
3. Retain a copy of the e-mailed request.

Information disclosed pursuant to this request shall not be further disclosed, except as specifically authorized by a subsequent order of the court.
