This statute is used VERY commonly and unfortunately is thought of as being completely ineffective. Usually those individuals committed for evaluation are released before the police officer has even completed the paperwork. Usually only a brief interview with a doctor is all that is done. There is NO requirement that the individual receive any follow up treatment. Firearms seized from these persons are often returned. There is no way to find out if a person has been committed in the past when they apply to purchase a firearm. These points are just scratching the surface of this issue.

There needs to be a police officer in every school. I often notice during nice weather many school doors are propped open allowing anyone to walk right in.
