

Hello,

I am here tonight as a husband and a parent. My wife and I have 2 children and are currently expecting our third; it is for our children that I am here tonight.

We are hearing the phrase “for our children” a lot after the terrible events here last month. Yet it seems that too many parents are shirking their responsibility of taking care of their children, and are instead looking to make the government do something about their child's safety instead. And in their haste in calling for government action on all levels, they are failing to see the end result, which is a more dangerous future, with fewer freedoms.

I am not here to support the 2nd amendment of the constitution tonight. Instead, I am here to support the whole constitution. The same constitution that gives everyone in this room the right to decide for themselves to own a firearm or not. The same constitution that gives them the very right they are using today to have free speech, and the right to assemble.

I cannot ever imagine suffering the loss that some people have gone thru in this community. But I am at a loss to explain how devastating it is to see people seemingly throwing away our constitution. Because while I fervently hope that no other horrible shooting takes place, we all know that no amount of laws will stop another one from happening. So when the 2nd amendment is governed to near extinction, what will people beg for the government to do then?

Should our children also never live in a country where their 4th amendment rights are intact? Should invasive and un-warranted searches be the normal way of life for them? Isn't the right to vote an extension of our right to free speech? Will our children be persecuted for speaking out against public officials? We have reached a point in our country's existence that we may never see again if we continue to ask the government to step in and create new laws. Laws that only target law abiding citizens. And no parent here should want his or her child to grow up in a country that used to be free. If we hand our children a country without the freedoms afforded to us by the constitution, than we have failed. If we dismantle the constitution in any way, we will have failed our children, we will be spitting on the graves of all soldiers who did not come home alive, and we will be turning our backs on the troops we so luckily have fighting for us now. If there was ever a time to rally behind the constitution once again, this is it.
