Chairman, Senators and Representatives,

I am a retired Police Sergeant with close to 20 years experience. I have served 2 different police departments during my career. I have learned to only deal with the facts not emotions, not to be subjective, but objective.

I would like to submit an uncomfortable truth, with the vain hope that it will not sound too callous. Mass shootings are small problem in our country and are always committed by criminals, which isn't to say that they aren't utterly horrifying in more than one way. Peoples' lives are destroyed, both literally and figuratively. First responders are left with vivid nightmares of what they had to deal with for the rest of their lives. However, if law makers were to prioritize their political attention on topics according to how many lives were at stake, mass shootings wouldn't even be on the radar.

I would be the first to admit that America doesn't have a gun problem but a gang/gang banger problem coupled with a bunch of mentally disturbed individuals. If you take the time to investigate all the shootings in schools over the last 10 years, you will discover that almost all of the shooters have been on some type of medically prescribed drug that induced killing or suicidal thoughts. Naturally, it would be tough to blame the medical profession, so politicians take the easy route and attack legal gun owners. They play on the emotions and phobias of non-gun owners, especially after the tragedy of Sandy Hook where small children were involved.

So what's the solution? First, we have to take a serious look at all the facts and circumstances surrounding Sandy Hook and other mass shootings. What do they have in common?

- 1. All the shooters were on medically prescribed medication and/or illicit drugs, which induced thoughts of killing, suicide or extreme anger and rage.

- 5. Most showed telltale signs before they committed their atrocities without being reported.
- 6. They all drove to the scene of the crime in a vehicle.

7. Most killed themselves upon arrival of the police or another armed individual, except for gangs and gang bangers.

A Means to an End. (a/k/a: The Solution)

- 1. Tighter controls on mental health regulations and the HIPPA laws to prevent the mentally ill, gangs and gang bangers from getting access to firearms, ammunition and magazines.
- 2. Educational programs, TV and social media advertisements that persuade parents be more involved in their kids upbringing and well-being.
- 3. Strict weapons, magazine and ammunition storage policy for all legal gun owners. Mandate gun safes.
- Restrict combat or killing themed videos until age 21.
