My name is Reverend Michael C Hills, I reside in Willington Ct. I am opposed to any and all attempts to alter, change and in away weaken my rights given to me by the Second and first amendments to the Constitution. I have reservations about writing you this letter as I and my family fear retaliation by the State of Connecticut first and foremost and retaliation by my government second. My deeply held conviction is that we will need these arms to fight a tyrannical government that already exist. You laugh, you sneer, and you snicker at what I just said. By God's grace and divine appointment I was adopted by Charles E and Mary V Hills of Rocky Hill Connecticut around 1958 or so. My mother was the one I talked to the most about God because you see when I arrived at her home I saw above my bed a cross of Christ with a palm attached to it. I saw the same cross of Christ in every foster home that I was in, but I didn't know what that stood for. My father a good Catholic taught CCD classes in our home. However it was my mother who gave me my faith in Jesus Christ. You see she would say were

stopping into the church to light a candle and say a prayer. I would ask why? She would say she had to take a test for an opening at her State of Connecticut Unemployment Divisions tomorrow and she wanted a little help from God. You see my mother would do her very best to study and then light a candle and ask God for favor. My mother always scored number one on the exams but was passed over time and time again by males with lower test scores. Until one day they couldn't legally by pass her anymore and she was promoted. My father was the assistant chief to the state Development Commission, boy did he have a nice office. Let me interject here the preamble to the state of Ct which states the following:

I never said anything to anyone I kept the experience to myself and pondered it in my heart for many years. However I knew my mother upstairs had done her best to get through to my teenage mind then she lit the candles and on her knees she called out to her heavenly father to deal with me. God answered her prayers, you don't talk back to drill sergeants in USMC.

In 1969 I Joined the USMC at 17 years old. My mother lit those candles now more than ever. Some years later I was married living in East Hartford working in the Diffuser group at Pratt and Whitney aircraft. Once again I was awakened to see my wife's long black hair on the pillow in front of my nose just as before I could not move. I was bound in my bed, I tried to speak to my wife to help me. I couldn't move my lips. I performed a secret my Heavenly Father taught me and Satan's angels left my room. Someone didn't want the prayer meeting established at St Mary's Church in East Hartford that I was starting. Yes I am now and for the last 35 years have been what is referred to as a born again Christian as my lord told

Nicodemus you must be born again to enter into the kingdom of heaven. John 3 verses 1 through 7

I met a man of God in church who told me that Satan had tried to kill me when I was two years old. I asked him how he knew that, you never met me before or understand the events of my life. He had as a Pastor the gift of knowledge a gift of the Holy Spirit there are many more gifts from God that we can have.

In September 2001 I was in bed nursing a broken leg I had received during a church softball game. I was talking to a friend on the phone when I saw the twin towers hit by a plane and then another plane hit another building I instantly told him this was an act of war.

When the towers fell I saw a face 40 stories high, I had seen that face once before as a preteen, it was the face of evil, SATANS face with horns and he appeared in smoke he was proud chin up saying he had done this and that it was evil. I panicked I assumed this was the end. I became a pastor within a year, a teacher, an exhorter, but no prophetic gifting that I could see. I went to another church meeting this time in North Heaven. There was an altar call and I went up for prayer and to get a word from God though another prophet Bob Hawley he was stopping in front of everyone and giving them insight. He walked by me and kept walking, he came back and asked me if I knew why he passed me by, I said no. He stated that God had not finished talking to him about me. He then said he saw Jesus Christ placing a crown on my head with the word revelation written on it. He walked away again and came back and said I have never in my 32 years of ministering seen this. Don't take this lightly.

The gift is starting to come alive within me and I have spoken into strangers lives. **However it is the recent series of events that have rattled me to my core.** I thought I was watching CNN on the aftermath of the tornados that blew though the mid states. I saw this man was helping those people hit and displaced by this storm. I wanted to help. I called Philip Cooper and told him of what I saw and wanted to donate to Marathon Ministry located in Gate City Virginia. He asked

me where I had seen him and I told him on CNN. He said he never has been on CNN nor has Marathon Ministries of Virginia. Our church, Asaphs Heart donated \$300.00 for gas for his truck. The truck took exactly \$300.00 when he went to fill it.

Then I saw the Travon Martin vs. George Zimmerman case. God showed me once again on TV what really happened! Then I began to understand that this was God and he was showing me these things.

I began to say to God, you know I have this gift, I want to be able to do something about situations before they occur instead of after the fact. I told God I wanted to help my government perhaps to stop terrorism events. God said you want see, I will show you your government.

The Lord told me to look at building seven NY 9/11. God told me to study and look into this. What could I see that I don't already know? I worked at Pratt and Whitney for 33 years in the Diffuser group. I machined those engines. These are not Pratt and Whitney engines at the Pentagon or in Shanks Ville Pennsylvania, are we blind? Do our eyes deceive us? There are no engine holes in the side of the building at the Pentagon! Those engines are 6' high and 9' long and weigh 6 tons each, yet not a mark on the side of the building the windows are still in tack no landing gear no luggage. Wake up, wake up!!!

These sites don't look like any crash landings I have ever seen. As a Ct residence I went to the implosion of the CNG building on Columbus Boulevard 11/01/01.
