

Governor Malloy, Lt. Governor Wymann and all member of Congress,

The purpose of this letter is to inform you that I oppose any, and all Gun Control legislation that may be applied to the citizens Connecticut.

I demand you not support, nor cast votes in favor of any gun control legislation as any of these regulations may only be applied to militia.

I, an American citizen, born in these United States, have been endowed by my Creator with certain unalienable rights.

Among the rights bestowed upon man are those so enumerated in our United States Constitution and the Bill of Rights and its amendments.

Our forefathers wrote the Second Amendment with peculiar punctuation in which it clearly declares by implication that:

If the "MILITIA" is not "WELL REGULATED" by "PEOPLE" keeping and bearing arms, the "MILITIA" becomes a threat to the "SECURITY OF A FREE STATE"

The "MILITIA" has no "RIGHT" to keep and bear arms in the Second Amendment, rather it is only "THE RIGHT OF THE ""PEOPLE"" TO KEEP AND BEAR ARMS (that) SHALL NOT BE INFRINGED."

Sir,

As an individual elected to office in representation of the People, your sworn Oath of Office demands that you uphold and support the Constitution, to let no Regulation infringe upon the Peoples rights.

At any moment you can not fulfill this oath you shall step down from this elected office or be recalled by the People.

It is your duty sworn by Oath to let not a free man be Regulated to arms Insufficient to preserve Liberty.

If at all, any such regulations of arms shall only be applied to the militia, government agents and police. The right of the People to keep and bear arms IS an unalienable right that shall not be infringed. The regulations of arms may only be applied to militia, not the People.

The Peoples right to keep and bear arms is the only guarantee of Liberty a free man may have from a tyrannical government. Let not that day come.

I keep and possess arms as my unalienable right.

All arms, ammunitions, magazines, related equipment and accessories I keep and possess for defense.

Defense of myself, my family, my fellow man, my Country and its Constitution.

Arms I keep and others that I may procure shall remain in my possession for so long as I so choose. May they be bequeathed to my family upon my passing so that they too, may keep them for their own.

I keep these arms for it is My duty, and mine alone to effectively defend myself from Tyranny, criminals and those that wish to do harm or disarm me.

These duties are not that of the government, State nor police.

A police officer as an agent of the public has no greater right, nor greater need, to effectively defend his own life than does a citizen under attack. As a pursuing agent, he may choose to retreat. But once under criminal invasion he has no choice, and is fighting for His life.

The life of a citizen in defense is as valuable to himself as that of the agent's is respectively, and, as a corollary of the right to life, the moral soundness of the right of self-defense can not be contingent on the frequency of its need.

Allowing weapons of individual defense to be regulated unequal to those of the attacker, or worse to be removed from the hands of citizens, and placed exclusively into the hands of a select group, certifies that citizens are expendable commodities, intended to become the fodder of a police state.

The Supreme Court of the United States as well as lower Courts have ruled: "Law enforcement agencies and personnel have no duty to protect individuals from the criminal acts of others ;

Surrendering the last outpost of individual defense is an act of homage by which lowly vassals declare fealty to the lord of "reasonableness," and eagerly take on the yoke of societal tyranny. The ultimate result of this misguided attempt to shield every citizen from folly is to fill the nation with fools.

It is for these reasons I have stated in this letter I inform you.

I shall not comply with legislation that should impede my abilities in defense of my life and Liberty, nor shall I submit to any unjust laws that would value my life to be less equal than those of any group, be they police, militia or any agent of government.

I shall keep and bear arms equally sufficient as those that would bear them against me.

I have broken no laws in exercising my rights, though through legislation being imposed that infringes upon the rights of the People, I may.

May all People and their elected representatives fulfill their duties to uphold our Constitution and preserve Liberty for all.
