
Dear Ms. Norman-Eady:

This is in response to the letter dated August 29, 2007, from the Bipartisan Committee of Review seeking information concerning an investigation relating to Senator Louis C. DeLuca.

The information requested was provided to this office by federal authorities for the purpose of deciding whether there was a basis for a state criminal prosecution and, if so, for use in such prosecution, which, of course, would also include appropriate disclosure to the court and to the defendant. Any further disclosure beyond those purposes should not be made unless appropriate under federal law and then, only if such disclosure would not interfere with the function of the federal agencies involved. The information is relevant to an ongoing federal investigation and to pending federal prosecutions and disclosure by this office would not be appropriate without prior approval of the United States Attorney's office.

If you still desire the information I would ask that you proceed in accordance with the procedures described by the United States Attorney in his letter of August 31, 2007.
