

# State Data Plan 2019 Update

In 2019, Executive Branch agencies continued to take steps to comply with Public Act 18-175 and to make progress towards the goals of Connecticut's State Data Plan. Agencies were asked to:

- Designate an Agency Data Officer, who should serve as the primary contact for inquiries, requests, and concerns about access to data at their agency, and who are responsible for implementing the provisions of P.A. 18-175;
- Develop an inventory of the agency's high value data and update it annually;
- Create an open data access plan to detail the agency data that will be made public as open data;
- Document the process for responding to data requests; and
- Complete a survey created by OPM on the legal issues surrounding interagency data sharing to support the drafting of a report for P.A. 19-153.

The chart below summarizes the steps taken by agencies to comply with P.A. 18-175 and to make progress on the goals of the State Data Plan. In addition to the designated Executive Branch agencies, two agencies opted to voluntarily comply with P.A. 18-175: the Office of the Comptroller and the CT Green Bank.
