

* Columns 6 and 6a: Joint Rule 9(a)(2)(B) provides that the Committee Bill Deadline is the JF deadline minus 17 days. As a result, Column 6 needs to be adjusted to reflect that "A" Committees may typically meet only on Mondays, Wednesdays & Fridays, and "B" Committees on Tuesdays & Thursdays. Column 6a makes this adjustment and has the correct dates.
