MEETING MINUTES

Tuesday, January 31, 2012

1:00 PM

I. The meeting was called to order at 1:08 p.m. by Chairman, Rep. Arthur J. O'Neill, 69th District. Members present were: Rep. Arthur J. O'Neill, Judge Julia L. Aurigemma, Rep. John W. Hetherington, Attorney Eleanor Michael, Attorney Neal Ossen, Professor Colin C. Tait and Attorney Thomas J. Welsh.

II. Attorney Eleanor Michael was introduced to the Commission as a new member. She was appointed by Sen. Donald Williams in his capacity to appoint members as President Pro Tempore of the Senate.

III. Attorney Welsh provided an update on the study of the Uniform Certificate of Title for Vessels Act, and noted that the study committee met each Thursday in January, 2012. Attorney Welsh circulated the study committee agenda for February 2, 2012, along with a copy of the study committee's current draft of the act. Attorney Welsh read the list of the final membership of the study committee, and the commission approved the final membership on a voice vote.

IV. Attorney Neal Ossen provided an update on the status of the study committee on the Uniform Partition of Heirs Property Act and noted that there has been insufficient interest in the topic to allow for the study committee to convene. Professor Tait indicated that he may be able to refer attorneys who are interested in the topic and willing to serve on the study committee.

V. A meeting of the full commission was tentatively scheduled for February 22, 2012, at 1:00 p.m., for the purpose of approving a final draft of the Uniform Certificate of Title for Vessels Act.

VI. Upon motion of Chairman O'Neill, the meeting was adjourned at 1:40 p.m.
