Below are preliminary fiscal impacts for the bills on today's agenda. These estimates were prepared under a short time frame and could be revised after further analysis. For bills on the agenda with proposed substitutes, the fiscal impact is based on the substitute language.

## **Bills Referred from the Floor**

1. **sSB 927 - An Act Concerning Seclusion and Restraint in Schools** - refer to fiscal note on file copy 72.
2. **SB 1030 - An Act Implementing Recommendations of the Task Force to Study Methods for Improving the Collection of Past Due Child Support** - *Proposed Substitute Language*.

**Section 1** allows judicial marshals serve copies of capias mittimus orders that do not result in a fiscal impact.

**Section 2** adds requirements to the State Marshal Commission which do not result in a fiscal impact.

**Section 3** of the bill is not anticipated to result in a cost to the Office of the State Comptroller. While a specific withholding may require an additional field or process to be programmed into the Core-CT accounting system, it is unlikely the additional functionality will be considered outside of the scope of normal system maintenance, and therefore will not result in an additional cost.

**Section 4** makes changes that do not result in a fiscal impact.

**Section 5** does not result in a fiscal impact to the Department of Social Services (DSS). This section prohibits the DSS or the Bureau of Child Support Enforcement from contacting the employer of an individual unless the individual has been adjudicated as the father of a minor.

**Section 6** may result in a cost of less than \$1,000 in both FY 16 and FY 17 to those agencies participating in the task force to reimburse legislators and agency staff for mileage expenses.
