From a 2015 Study on Veterans Affairs: Office of Advocacy and Assistance

H.B. No. 5347 (RAISED) AN ACT IMPROVING CUSTOMER SERVICE TO VETERANS BY THE ADVOCACY AND ASSISTANCE UNIT OF THE DEPARTMENT OF VETERANS' AFFAIRS BASED ON A PROGRAM REVIEW AND INVESTIGATIONS COMMITTEE STUDY. (PRI)
